REPORT ON THE ANNUAL MEETING

A Sheriff's Office Substation for Mt. Lemmon is among the items on the bonding proposal voted on by the people of Pima County last Tuesday. If this proposal carried, work on the substation should start this spring.

This was the best news dropped on our organization by the panel of county employees at the annual meeting of the Homeowners' Association recently. Our guests were D. A. Dichico of the county highway department, Bud Dooley of the county sanitation department, and Alex Garcia of Planning and Zoning. Ken Sharman, County Manager, inferred that unless we tried to straighten up these three things, our Zoning, our road situation, and our polution problems - we couldn't expect much help from the county in our continuing battle with the Forest Service. But, he stressed that we would receive full support if we went to work on these problems immediately.

Approximately 120 people were present for the talk and the dinner. New Board Members elected were Dr. Jim Bennett of the Loma Linda area. Gerry Hackney and Bill Rhind, both from the Summerhaven area.

Bob Zimmorman, our Prosident, gave a brief speech on what the group had accomplished this past year and what the major aims for 1974 would be.

He also gave the following list of new committees for this year and the chairmen. If any of these committees interest you, give the Chairman a call or drop us a note and we'll forward your name to the correct Chairman. Two committees, Forest Service Liaison and Pima County Liaison are without Chairmen. If you feel you have the time and interest to work on either of these, give Bob Zimmerman a call some evening. FOREST SERVICE LAND EXCHANGE

A group of Association members, led by Gerry Hackney of our Logal Committee met with Mr. Perry of the Forest Service concerning protests filed by many of our members on the proposed Forest Service Land Exchange program concerning Mt Lemmon property.

Mr. Perry re-affirmed that the Forest Service goal is to eventually take over all of the private land on our mountain. As to how they plan on doing this when all the land that can be bought is purchased, Mr. Perry did not elaborate.

SPOTLIGHT.

"TONY ZIMMERMAN"

If you wonder what homemade chili at the Mt Lemmon Inn, a two by four from the Sawmill, or a new road on the mountain have in common, you can stop wondering. The answer is the subject of our SPOTLIGHT for this month, T. H. ZIMMERMAN

At the age of 81, Tony is one of the most active and industrious people on the mountain, outworking his employces who are mostly less than half his age. He oversees the Mt Lemmon Inn, Mt Lemmon Sawmill, Mt Lemmon Construction Co., and Mt Lemmon Realty. Because of all this activity, he is often referred to as "The Old Man of the Mountain."

Born in Osborne Kansas, Mr. Zimmerman came to Arizona as a young man in 1912. It wasn't until 1925 that he came to Tucson, where three of his five children were born. All this time he was teaching and working in construction or ranching on the side.

A hunting expedition first brought him to the mountain in 1937. And he liked it so well that he started buying property on the mountain. That same year he started working for Pat Jenks selling property. This was in addition

to a fulltime job teaching at Safford Junior High. in 1943, though, Mr. "Z" retired from teaching and devoted his full time to Mt Lommon.

Zimmermans bought the Mt Lemmon Store in 1942. This was located near where the current Inn is located. And in 1943 they added the Catalina Guest Lodge to their properties. (This is now Mrs. J. B. Borden's cabin on Carter Canyon Road.) In 1945 Mr. Zimmerman sold this Lodge and brought the old Neoli Lodge at the corner of Carter Canyon and Douglas Street. Because of the beautiful pines around it, he renamed the place the Pinetree Lodge. But both the Lodge and the beautiful trees burned down in 1950.

Also in 1945 Mr. "Z" built the store portion of the Mt Lemmon Inn and five years later the hotel portion was completed.

Tony holds the record of being the first postmaster on Mt Lommon. But back in 1943 this was a voluntary job with no salary and no office. Mail was distributed by Mr. Zimmerman at his Mt Lommon Store.

By 1964 all the Zimmerman children were grown and away from home, so Tony decided it was time to sell the Inn and for he and Sena to do some traveling

But the Mt Lemmon Inn couldn't get by without the Zimmermans, so in 1971 Robert Zimmerman, the youngest child, came back to the mountain. He and his Dad romodeled the Inn and reopened the restaurant portion in January 1972. Plans are underway for a renovation of the hotel portion which they hope will be open within a year.

This past fall Pima County Schools recognized Mr. "Z" for all the years he taught in the county school system and for all his years on the mountain by naming the school on Mt Lemmon, "T.H. ZIMMERMAN ACCOMODATION SCHOOL."

As for the future, Tony has great plans. This summer the youngest Zimmerman daughter, Norma Marquard and her husband Dick plan on coming back to the mountain and helping with the Zimmerman Enterprises.

Maybe now Tony and Sona can take some time off and do that traveling. Hopefully they can take a long trip through Mexico and head even deeper south in Honduras and South and Central America.
