# ENVIRONMENTAL PROTECTION AGENCY AND PROGRAMS 201 and 208

Under the original 201 program Pima County was to upgrade the sewage treatent system, but the 208 program came up under which the State would survey all
streams and rivers on a non-point pollution basis. The Committee selected Sabino Creek as a prime target. However, using data prvoded by the University of
Arizona the engineers for the P.A.G. (Pima Association of Governments) 208
found that the cabins were not the polluting problem, but rather that horses

and dogs were the main polluters. The water samples were taken above the treat ment plant, but nevertheless they said the treatment plant should be eliminated - the environmental groups want no discharge whatsoever into the creek. They want it drinking and swimming clear. Pima County wishes to convert usbe onto septic tanks, although when the system was initially put in it was push as being for our best interests - they insisted.

On July 7th at the Zimmerman School on Mt. Lemmon and on July 21st at the Pima County Board of Supervisor's Hearing Room and sponsored by Pima Association of Governments, what are claimed as the two major sources of pollution in the Upper Sabino Creek Watershed - the Mt. Lemmon Wastewater Treatment Plant and sewer system and the horses and animal corrals near the creek - were brought up. The P.A.G. recommendations for handling the situation were as follows:

- 11. Amending the existing 201 plans for community sewage treatment facility and to place the existing 45 connections on an appropriate onsite disposal system.
- 2. Establish survey procedures to locate improperly functioning septic tanks on private and Forest land. Deficient systems <u>must</u> be improved or replaced.
- 3. Review and develop new standards for the construction of new on-site disposal systems.
- 4. Construct and maintain no discharge public restroom facilities in Summerhaven for solid waste residuals reduction and prevention.

Under this latter recommendation are (a) Establish an educational program to reduce littering by recreationists using Upper Sabino Creek Watershed. (b) to arrange for animal waste disposal and prevention through possible removal of horses and other livestock from Upper Sabino Creek Watershed. (c) Establish routine programs to round up stray dogs on the Upper Creek Watershed. (d) Establish an education program to encourage water conservation by Summerhaven and Forest Service residents. (e) Establish a land use planning program in which development on Sabino Creek reflects water quality goals. (f) a continuing water quality monitoring program should be established to assure the recommended program is achieving water quality goals. (g) the continuing water quality program will evaluate the Mt. Lemmon pollution abatement program.'

The above new standards were adopted Wednesday, August 10, 1977, by the state Water Quality Control Council. To meet the standards, the County Board of Supervisors will be asked to pay the cost of installing individual septic tanks to each if the 45 cabins served by the county's sub-standard plant, said plant being closed down instead of upgraded. Bruce Scott, a state water quality control officer, said that "Ideally, in a couple of years, Sabino Creek will be what it was 20 years ago" and the new standards are "as tight a health standard as you can come with."

Their new proposal would provide septic tanks only to those residences now linked to the county service. The remaining cabin owners would be required to meet upgraded standards on their own if their existing systems were found in adequate. All this was rushed through as the county was pressed to meet a federal dealine established by the Environmental Protection Agency. The supervisors allocated \$284,000 to improve sewage treatment fo Sabino Creek area residents and expanding its service to other cabin owners, but it is unlikely the efforts would have cleaned the affluent enough to meet state standards.

The high standards were set in response to 'public pressure' to protect the creek - the same public who gleefully toss pop cans, beer cans and bottles and wet garbage up and down the length of the Hitchcock Highway, to say nothing of along the Butterfly Peak Trail, Sunset Trail, Lemmon Rock Trail and the Palisades Trail from the Girl Scout Camp to Lower Sabino itself.

At last word the Board of Supervisors had turned thumbs down on the updating of the sewage treatment plant, so we shall see what develops and keep you informed in future issues of the 'Mt. Lemmon Echoes'.

## MT. LEMMON WATER CO-OP CO.

The Co-op hired Mr. Leon Luke as Maintenance Man in June. Mr. Luke has spent his adult life working in plumbing and in design, construction and operation of water distribution systems. With knowledge of welding and other skills he is well qualified to tackle the multi-faceted problems of his job. He, his wife Dora, and their children live in the Andre cabin in the village. Their phone number is 791-9739. Mr. Luke is available for private jobs after 3:00PM any day, and all day on his days off which are Tuesday and Wednesday. With the heavy rains, the water supply is excellent. Miner's Ridge Tank had to be partly emptied to permit replacement of some valves, and is now being refilled. All other tanks are full, and there is more water than can be pumped.

The FHA loan is reported close to completion, but the federal government

may require further reports and paperwork from the Co-op.

# MT. LEMMON INN

Although all of us who live in the valley and on the mountain sadly know, we have many members who live in far away states who do not about the fire in the early morning hours of April 29, 1977 that burned the Mt. Lemmon Sawmill & Co. Restaurant to the ground. The original lodge was built in 1945 as a restaurant and country store by Tony Zimmerman with the addition of a two-story structure used as a hotel built in the early '50s. The Inn was the second commercial building in Mt. Lemmon to burn down within the last ten years - the 50 year old Ponderosa Lodge was destroyed in 1970.

Only the stone fireplaces were left, but it is hoped that the Inn - which was Mt. Lemmon to many folk in the valley - will arise like a Phoenix from the ashes and be going full blast again. Not only was it the entertainment center for potluck dinners and other mountain gatherings, but it was also the site for gatherings, in the summer, of the Tucson Ecumenical Council church services for as many of the 300 mountain residents who wished to attend.

In the meantime, the 'Chuck Wagon', just across the street from the Inn site, is being run by Fran Hayes and Bob Zimmerman and there you can get just about the best Patty Melts, hamburgers and accompanying 'goodies' as can be found anywhere in Pima County. To quote the Unsinkable Molly Brown "We ain't down yet!".
