# WATER NEWS

Pima County is in the process of redoing both Carter Canyon and what used to be called Upper Sabino, but now is referred to as Cold Springs Canyon. They are also doing repair work in Marshall's Gulch. So far, the water interruptions have been kept to a minimum in both canyons. Quality Paving, the contractor, is bringing the roads in both canyons up to Pima County standards, which I assume that the County will keep the roads maintained. One would hope that the County would also keep the two canyons plowed this winter, however, this doesn't appear likely. Chuck Huckleberry, Pima County Engineer, informed the Homeowners Board in a recent meeting that the mountain can only expect the bare minimums in snow removal this winter. The problem is that the County's overtime budget has been slashed to the bone and that the plowing of the Mt. Lemmon Highway is done largely on overtime. Mother Nature has a habit of snowing a great deal during hours other than from eight to five. The crazy part of this is that it is cheaper to use overtime to remove the snow as it falls than it is to wait and remove deep snow during regular hours.

The two chlorinators and transfer pump installed by Ferguson, the contractor, and engineers be Cella, Barr, and Evans have failed to perform properly. The chlorinators have only worked for very short periods of time. I have been unsuccessful to date in getting the engineer to pin point the problem. The pump is now again back at Ronstadts for repair. It is fortunate that these failures have occurred after the summer season when the water usage has dropped, so that the old manual system is able to keep

up with damand.
