#### FROM YOUR PRESIDENT

You all, I hope received a Forest Service letter about the purposed lease fee increase and the meeting at Mansfeld Jr. High. Would you believe I didn't receive one. If you were there you would probably felt pretty frustrated. I have tried to see Steve Plevel more times than I care to count, but he seems to be either out of town or in all day meetings, however, I did spend about 2 hours with Alan Jatan, who is in charge of all the recreation on the mountain. Some of the questions I ask ( and these were all suggested by members were):

1- How can you put a fair market value on land that is not for sale?
The land has no market value if there is none for sale.

2- If the Forest Service does not agree with the premise and apparently you don't, then we suggest that you use a figure similar to the Co. Assessor, in a new appraisal, the County has set a full cash value on similar lots of \$4,500.00. Even this does not seem just, as we may do nothing to the addition of our cabins or on the land without permission; Yet we are told to allow strangers to picnic on this land which we pay a fee.

3- The Administration has talked long and loud about reducing inflation. If current dues are raised, more and more people will try to buy the remaining lots on private land, thus driving the cost etc.etc. It becomes not a vicious circle, but an appalling upward spiral.

4- We understand the Forest Service is again buying deeded lots, is this the beginning of an apparent effort as in 1974 by the Forest Service, to buy as much private land as possible, then perhaps condenm the rest?

5- What is the charge per acre for grazing and mining purpose of Forest Service land?

6- I have recently received copies of, FOREST FEEDBACK, which is a study which cost the Forest Service \$500,000.00, LAND and RESOURCE MANAGEMENT PLANNING, and THE PUSCH RIDGE WILDERNESS PLAN. Are you people so busy writing these surveys, that you have neither time nor money left for the services we used to receive? Such as annual inspections, the daily trips to each area, the grading of roads at the beginning of the summer instead of at the end?

7- How many men and women in the Forest Service are employed directly or indirectly for the Calalinas?

8- Will you give me a breakdown of what you spend each year on those of us on leased land what your income from it is? (This he told me would not be too difficult to do).

9- Please place trash cans in all picnic areas, we did not see any last year.

10- Please seriously reveiw the purposed charges for the Willow Canyon area, they seem to be disproportionately being discriminated against even more than the rest of us. They also report that the Forest Service has been felling trees in Willow Canyon. People with permits saw the wood and leave the mess of branches on leased land. Let's face it. Would these people like it if we came in their yards for picnics, dig up plants, or perhaps cut down a tree or two, or would

any member of the Forest Service like these things to happen in their yards?

11-It would not be too difficult to work out a fairly fool proof system of charging those who come up for the day to (we hope to enjoy the mountain, but who do 99% of the littering and damaging to the road. Since we now do the policing and the cleaning, whatever cleaning and policing is done, please don't add another burden to us. He promised to give me answers.

We have had no fires of any kind since the Gavitt fire, which we consider GREAT. We have more training sessions coming up and are hoping for several to turn out for these sessions as they will be put on by the State and National Fire Academy.
