We have mailed large packets to both Senators, our Congressman, the Director of the Office of Management and Budget, the Secretary of Agriculture, and the Chief the Regoinal Director, and the local Supervisor of the Forest Service.

This will be the third copy of our Mt. Lemmon Echoes which we have mailed to everyone of the permittees on the list the Forest Service furnished us. The extra cash has been about \$75.00 on each issue. For those members who have not yet sent in your dues, PLEASE ! we need the money. And for those of you who do not belong, remember we are making this effort for every permittee in the Catalina's. Of course belong to your neighborhood Association, but also please join the Mt. Lemmon Homeowners Association. We are the only one to which ALL cabin owners in the Catalina's may belong. Many of you now belong to both associations.

We have spent about \$750.00 just to date, and have no way of knowing how long this struggle will last. MT. LEMMON WATER NEWS

We are still experiencing trouble with the water transfer system that was financed by the Farm Home Administration. The main pump has burned out again for reasons which neither the engineer or contractor seem able to pinpoint. Pump experts at Ronstadt Hardware have expressed the opinion to members of the board that the sump and sump supply line is inadequate to meet the demands of the pump. Ronstadt Hardware is to install a new pump which should shed a little light as to what is going wrong.

\$20,100.00 in disaster aid has been received by the Cooperative. Most of the money is slated to go to Fergerson Construction and Ruiz Engineering for the design and replacement of the main trunk lines lost during the last flood in Carter Canyon. The balance will be used to make a number of

small repairs of damage caused by the same flooding both in Carter Canyon and Sabino Canyon. The disaster aid can only be used to repair flood damage with the stipulation that the repairs result in no improvement in the system. All repairs must be completed by 1 July 1981.

The annual meeting will be held 30 April. We are hoping to use the Moose Lodge as was done last year. Notice of the meeting will be sent out

to the membership about 10 April.

At the last annual meeting the membership was given an operating budget which indicated that the unpaid bills plus the operating expenses would exceed the income as provided by the water rates set by the Arizona Corporation Commission. This has proven to be an accurate prediction. It now appears that this year will run about \$4,000 to \$5,000. in the red. With the imposed rate structure, the Board had accepted operating in the red as an operating condition for this test year. The challenge to the Board has been how to keep the Cooperative solvent. I don't think any Board member had any idea of how much work would be required to meet that challenge, but it was met.

It is clear to all concerned that in order to keep the Cooperative in operation two steps must be taken in the very near future; (1) assess the membership to bring the current deficit back into focus and (2) apply to the Corporation Commission for an appropriate rate increase. Both

these matters will be on the agenda of the annual meeting.

FIRE DEPT. NEWS

If you will remember back in Nov. I told you of a letter that I had wrote to several political offices and the Regional Officer of the Forest Service about the way the Forest Service personnel were doing with the Fire Dept. And that I had received a letter from Jim Hickman of the Regional office, telling of an investigation that he had been assigned to in this matter. On Feb.25, 1981 this meeting was held at Palisades Ranger Station with Mr. Hickman, Steve Plevel, Ken Weisenborn, John McKelvey, Carl Jones of the State Land Dept, and from our side were Charles King, John Montgomery, Katie Dusenberry, Freddie Hershberger, of Senator Goldwater's office, Fran Zimmerman and myself. Also were our chief and several members of our department and also several other Forest Service employees.

We discussed the positions of each department and the complaints that were in the letter I had sent. We spent about 2 hours discussing and understanding the unique situations of each on the mountain. We now have full cooperation from the Forest Service, from Albuquerque on down to Tucson and the Mountain. They will be furnishing us casch to help fight forest fires and their men can train with us and attend our meetings. We feel real good about this accomplishment and the Forest Service personnel has ask for other meetings to organize better communications between the two departments. Their two leading trainers will be training our men and their films on forest fires have been made accessible to us to use for training. We will be signing a Mutual Aid agreement with the State Land Dept. so that we can help the Forest Service with fires outside our District, should they need us. This is another first for the Mountain.

Now the hole has been dug for the Fire hydrant and hopefully it will be installed in the next day or two. If it proves satisfactory we will

be purchasing more.

The Van is being equipped inside and will be completed in about 45 days. This will be made accessible to the Forest Service too. This will be ready for the summer heavy traffic on the mountain. It is being equipped for State Certification, this way if we have to take someone off the mountain we will be equipped for it.

Saturday the 7th. and accident resulted in our department aiding and doing the wash down. This was one of the results of our meeting with the Forest Service the 25th. It is a shame the impatience of the human race. They don't acknowledge a red light, a fire truck, or sheriff vehicles. There was a fight amongst some, a man at the Ski Lodge was thought to have a heart attack, but wasn't. The road was lined with cars on both sides and the ambulance trying to get to the Ski Lodge. Also vehicles passing the fire truck and other vehicles in all the traffic. Mike and Doug our Deputies handled it very nicely.
