

The summer is nearly gone and we are moving into the fall on Mt. Lemmon. We have had a busy August and a crowded Labor Day and look forward to Oktoberfest. It feels like the year is nearly over.

August 15th a mailing was by bulk mail to homeowners about the meetings on August 25th. Needless to say, the Post Office had some trouble with that mailing and some people received it within a reasonable time while others received it after the meetings occurred. We are complaining and asking for our postage back and apologize to all who were not able to attend because of the mix-up. There is a report in this issue about our meeting with Lt. Rose of the Sheriff's Department.

Jerry McLain of the Transportation Dept. of Pima County came up to talk about roads. He is planning to "blitz" the roads by adding material and grading them after the rains are ended. Repairs to the highway are continuing and plans for winter are formulated.

He is planning for "average" conditions. On the average there are 16 storms on Mt. Lemmon in a given year. Last year there were exactly 16 storms. During a storm the snow falls at an average rate of 1/2" per hour. At the first hint of precipitation the "SNOW PATROL" will be established which means a person will be sent up here to patrol for snow or rocks. When

the snow begins to fall the plane for clearing the roadway is: clear one lane, then the second lane and then the pullouts. In this way several passes are made and the road stays relatively clear throughout the storm. In the event of a blizzard people will be "stuck" until they can get it cleaned up and people can expect

road closings and inconvenience just like life back in the north of this country -- does anyone remember??? (I used to pray that the schools would close in Chicago but they rarely did.)

The Transportation Department depends on people on the Mountain to tell them about the road so feel free to give reports by calling 882-2639.

This winter, Bob Zimmerman has a contract again with Pima County to clear local roads but unlike last winter, he will NOT be doing driveways. If you want your driveways done you will need to do it yourself or hire someone to do it for you.

The KCEE promotion for the Fire Department was a huge success and Leslie May deserves congratuations for a job very well done. Thank you Leslie, we appreciate the work that went into raising a substantial amount of money.

DISCUSSION WITH LT. ROSE - AUG.25

On August 25th, the Mt. Lemmon Homeowners Association arranged two meetings in one day. The first featured Lt. Rose from the Pima County Sheriff's Department and this report will deal with the information he shared with us.

Lt. Rose is the Commander of the Rincon Station of the Sheriff's Department and he is responsible for all the personnel and anything done is his district. He explained that Pima County is one of the 5th or 6th largest counties in the U.S. and comprises 9,420 square miles of area. There are 5 districts in the county; Ajo, San Xavier, Catalina, Green Valley and Rincon. The Sheriff's Department as a whole is set up in two sections -- Administration and Operations.

In the Rincon District there are 35 people working. There are different kinds of Deputies: Patrol Deputies who drive cars in valley, Detectives, Administrative Deputies and Rural There are 5 Deputies. Deputies one of whom patrols for the ranches in the valley and 4 who are assigned to Mt. Lemmon. Fletcher and Jack Simmons primarily assigned to the Forest Service and Mike Duffey and Doug Myrvold are assigned to Summerhaven all the Deputies work although throughout Mt. Lemmon.

The Homeowners asked several questions in advance:

- 1. What are Deputies expected to do? ANSWER Their job is routine law enforcement which include traffic, any breaking of criminalaws and assisting Forest Service personnel. They are here to preserve the peace and patrol all over the mountain.
- 2. What are Deputies NOT expected to do? ANSWER Deputies DO NOT handle any civil disputes. Lt. Rose has given orders that Deputies do NOT pull people out when stuck—they are to call a wrecker for an individual who is stuck. In certain emergency situations they will move a vehicle if necessary.
- 3. Do Deputies patrol areas of Mt. Lemmon Daily? ANSWER In a shift someone usually gets down to Molino Basin and the Deputies do patrol all of the areas of Mt. Lemmon including the camparounds.
- What problems does Mt. Lemmon pose which are different from other areas of Pima County? ANSWER 90% the calls to the Sheriff' Department come from the valley su the priority is down there, not up here. Deputies up here have fourwheel drive vehicles because of the terrain. There is more public relations kind of work up here because of the large number of visitors and because the Deputies who live here are part of the community. The Rural Deputies assigned to Mt. Lemmon are special because of the unusual environment. The work up here is intense and the Deputies who live up here, Mike Duffey and Jack Simmons, go to Tucson on their days off to avoid exhaustion and burn-out. Traffic problems on Mt. Lemmon difficult because of the single road up and down the mountain. The road can be shut down at the base for major violations. The snow in the winter is a difficulty the rest of Pima County does not share.
- 5. Is there another way to reach a Deputy than through communication.
 ANSWER The ONLY way to reach a Deputy is through communications at 911 or 622-3366. If there is an

emergency after 11.00 p.m. all calls for Deputies go first to Lt. Rose who then decides whether a neputy should be called. If he cays it, the Deputy is called. For non-emergency situations people will be told that a Deputy will be notified when he comes on duty.

- 6. Are there times when NO ONE is up here? ANSWER Generally speaking there are 2 people here at one time and the shifts extend from 9:00 a.m. to 11:00 p.m. On rare occasions, due to illness, vacations, etc., there are no Deputies here but someone ALWAYS be sent from the valley by car or helicopter depending upon type of emergency. Deputies who are here past 11:00 p.m. are always on-call for emergencies.
- 7. Is it legal to drink beer or other alcoholic beverages when picnicking from a vehicle? ANSWER Drinking on county right-of-ways is illegal. Violators will be asked to move and then be cited if they ail to do so. Picnicking in designated "pullouts" is legal, however, consuming alcohol there is not legal. Passengers may drink in a moving vehicle, but the driver may not.
- 8. When many people are expected the highway, for whatever reason, doesn't the Sheriff's Department need to add personnel to deal with it? ANSWER There are many more people here on holiday weekends as a rule, but expecting businesses are many people it is suggested that Deputies be hired (as they were by Alpine last year Oktoberfest). The Sheriff's Department tries to provide personnel as necessary throughout the County.
- 9. Who decides to close the road in the winter? Is it up to the Deputies? ANSWER Usually the 'ecision to close the road comes from Lt. Rose who explained that he takes reports from different sources then consults with his

Deputies and decides whether to close the road. Any Deputy on the scene can decide when conditions warrant closure of the road and they will place restrictions in the winter. If the road is CLOSED to one it is closed to all including residents. The order restrictions is as follows: Chains or four-wheel drive. Four-wheel drive and chains on all four wheels. 3) Four-wheel drive and chains on all four wheels and residents. 4) Emergency vehicles only.

- 10. Are Deputies obligated to pull people out when stuck in the snow? ANSWER Deputies do not pull stuck vehicles out of the snow. It is against regulations. They will call for a wrecker to come from Tucson.
- 11. Can Reserves be stationed at the bottom of the highway more often to warn people about bad road conditions? ANSWER Deputies volunteer their time and usually work days in other jobs so it is difficult to get them at that time. There are 10 Reserves in the Rincon District and Lt. Rose can usually get 2 or 3 to respond. They hate road blocks and check points -- they want to patrol with the Rural Deputies and do something more useful or interesting. Lt. Rose asks for people to hand out leaflets he usually gets a very poor response.
- 12. What can happen when signs about four-wheel drive and chains are ignored? ANSWER Anyone without chains can be cited for ignoring a sign and will be cited for both ignoring a sign and for whatever kind of accident occurs when doing so. In other words, put the chains on whether you think they are necessary or not.
- If "No Parking" signs are posted and are supported by an ordinance

then illegally parked cars will be cited.

According to Mr. Lewis of the U.S. Forest Service the public may cross leased lots but they may not picnic or camp on them. If they do, call the Forest Service and complain.

For the three weekends of Oktoberfest it is suggested that the businesses hire off-duty Deputies at \$10.50 per hour. They are deployed in pairs and they are under the command of Lt. Rose when they are up here as if they are on duty and must follow all the regulations of any other Deputy.

The purpose of this meeting was to allow the community to become more familiar, more aware and increasingly cooperative with law enforcement on Mt. Lemmon. We feel the purpose was accomplished and we are very pleased that Lt. Rose could join us and share this information with us.

Fire Dept. News




YES --- there really is a new bear on Mt. Lemmon. Over the past couple of years, rumors have abounded that bears have been relocated on Mt. Lemmon This time the rumor is true. Eddie Cocking, Wildlife Manager of the Game and Fish Department verified the fact that a black bear was relocated on Mt. Lemmon approximately three months ago. Several residents have been fortunate enough to see this bear as it attempts to find a new home. The bear is a two year old female who was originally caught in an apple orchard in the Huachucas, tagged, relocated, and then turned up again in the same apple orchard a year later. This time, they hope that this bear will stay put in the Catalinas. The bear has tags on both ears, one metal and one red, so do call Game and Fish if you see it. She weighs 80-90 pounds, and when mature should weigh about 150.

These bears are omnivores and will take the path of least resistance to locate food - berry patches, apple trees and campground trash bins are usually favorites, so you may see this bear in any of the above.

Game and Fish estimates that from Bear Research at the University, there are about 10-12 bears in the entire Catalin Range, so your chances of seeing a bear are very slim. If you should happen to run into a bear, however, make alot of noise, and the bear will be scared away.

Bears start their denning-in in October, but they do not have a 4-5 month sleep hibernation as many of us would believe. They either dig a den or just hide in a depressed concealment, coming out every so often to stretch or forage for a meal. They are not particularly ferocious at this time, as you might think. Dogs, however, are their natural enemy, and if your dog should happen to chase one, it just may wind up as a mid-winter snack for a bear.

According to Game and Fish, male bears in the territory will be seeking out our new femme fatale for mating. Perhaps, in a year, we will have some cubs to add to the bear population of Mt. Lemmon.
