BUDO

There seems to be a renewed interest in the martial arts these days, judging by current movies, magazines, and conversations overheard at the gas station. These kinds of exposure (via Hollywood and media) have created of misconceptions about martial arts in general. I'm not professing to be an expert, but I do have a little understanding of one modern Japanese martial art, Aikido, which was established in the 1930's. Although relatively modern, Aikido is well founded in tradition.

This tradition is known as Budo, (the way of the warrior) in Japan. The first part of the work Budo (Bu) is interpreted as meaning martial art, but its literal meaning is "to stop the fight". "Do" in Budo translates as "the Way". In Budo, the point is not only to compete, but to find peace and mastery of the self. It explores in direct experience the relationship between ethics, religion, and philosophy. It's association with sports is a very

Bushido, the way of the Samurai, grew out of the fusion of Oriental Philosophies. Bushido can be summarized in seven Principles:

1). The right decision, the right attitude, the truth. When we must die, we must die. Rectitude. 2). Bravery. 3). Universal love, benevolence toward Mankind; compassion. 4). Right action—courtesy. 5) Utter sincerity; truthfulness. 6). Honor and glory. 7). Devotion, loyalty.

Martial arts today seem to be a fashion or sport and are loosing the spirit of the Way (Do). People think after a few classes or even a few years, "I've had enough classes, I understand.", but it is not a school you graduate from, rather, a way of life.

goal of Budo is not The aggression or domination, but mastery of yourself, which is much more difficult than beating a visible opponent. One master, upon being asked "How many years do I have to practice?", replied, "Until you die.". This same man, Master Deshimara, emphasizes that true martial artists take their spirit from budo rather than sports: he says "I have nothing against sports, they train the body and develop stamina and endurance. But the spirit of competition and power that presides over them is not good, it reflects a distorted vision life. The root of martial arts is not there. In the spirit of Zen and Budo everyday life becomes the There must contest. be awareness at every moment getting up in the morning. working, eating, going to That is the place for the mastery of self."

Hollywood's representation of martial arts can be entertaining and inspiring although sometimes misleading.

The following is an excerpt from the minutes of a special fire district board of trustees meeting "Fred Keers held July 17, 1986. has approached the trustees with a proposal to replace the present emergency vehicle with a pumper unit which would carry the rescue equipment and an EMT, but not have any transport ability and would loose the ability to move the victim out of freezina weather, rain or snow into a warm, secure environment of the present rescue vehicle. This change would enhance the fire protection capability of the district reduce the emergency services capability."

This is a real tight squeeze for us all. But the board has a legal mandate to provide fire protection district on a budget which comes from your already maximized tax Funding emergency medical services operations out of the fire budget is at odds with this mandate. only is the funding inadequate to support both operations, the time and personnel demands due to EMS calls are tremendous in comparison to fire calls. The burden becomes even greater when you realize that, except for Chief Keers, each of us is a volunteer.

The Board of Trustees acted responsibly faced with this situation. They called the July special meeting and invited representation from all aroups thought to have obligations provide services here -U. S. Forest Service, Pima County Board Supervisors, Pima Sheriff's Office, Pima County of Transportation, Department Arizona Department of Health Services and Arizona Emergency Medical Services.

USFS response was that they are currently funding the Pima County Sheriff's Office to provide law enforcement and emergency medical services in forest areas and their budget can go no further. sheriff's office states that their primary duty is to law enforcement but that with the USFS funding. all the rural deputies are trained as emergency medical technicians and carry some basic equipment on their vehicles. Pima Transportation had the suggestion that MLFD charge non-taxpayers for services. This may be possible -

MT. LEMMON WATER CO-OF

The board has had a busy productive June and July. decided on the engineering firm of Arthur Beard Engineers, Inc. to do an engineering study of our water system. This will provide us with an expert analysis of the existing system and potential impacts of future expansion.

Mt. Lemmon Water System Improvement Project was approved Pima County Community Development Block Grant funding in

the amount of \$75,000, thanks to

the efforts of Michael Stanley.

Fred Keers, and Roy Garcia. The money will be used to replace the 25 year old 1 1/4 inch main pipe from the 500,000 gallon main storage tank to the pump house in the village. It will be replaced with an 8" minimum line which will improve water distribution and enhance fire protection.

We've been working with the Arizona Department of Water Resources in trying to perfect our spring rights. At this time we have access to nine springs but no certificates. Michael Stanley and Jim DuBois are working hard to change that.

Since the beginning of May, we have taken over the operation of the Forest Service water system on a trail basis. This involves the operation and minor maintenance of a system which services Loma Linda, Sykes Knob, Bear Wallow, Spencer Canyon and Palisades. We will know at a later date whether this will be a permanent arrangement or not.

Under his guidance, Pima County Highway Department is in the process of paving our back roads which includes "two shot paving" in some areas and the more permanent asphalt paving in other areas. By the time they are finished, several miles of roads will have been paved. Even upper Phoenix is to be paved, I hear!

The Highway Department has also widened roads and corrected drainage in several areas which will be much appreciated by all this winter.
