

## NOTES FROM THE CHIEF

As we start into the new year, it seems the types of calls we are getting are the same as last year. The only difference is

now there are more of them. This year, as last. the calls are dealing with people playing in the snow. Most of the problems are with tubing and sledding accidents. So far this year, we have responded to 26 calls, only one was a resident of Mt. Lemmon. For this reason. we are trying to get Pima County to pick up part of the tab for running your fire department. Last year we responded to 179 calls. Of those calls.

only 16 rescue and 7 fire calls were for residents or their guests. It does not seem fair for you, the tax payer, to foot the bill for the fire department when you only use 13% of the service.

More bad news. The state is trying to eliminate the fire district assistance tax. This tax, which is paid by all residents of the county, is what keeps our doors open. This year it amounts to \$56,000. Without it the

Mt. Lemmon Fire department would have to close its doors as a manned fire station. We will keep you informed to the progress of the bill #2251 in the House of Representatives. Hopefully, it will be tabled in committee. This in effect will kill it for the next year.

Now for some positive news. We have 2,000 feet of new hose. This hose was purchased with funds donated by residents of Mt. Lemmon. This hose was

badly needed and will assist us during both forest fires and building fires. We are putting together specs for a new fire engine/tanker. We hope to get the funds for this through a grant. The engine we are using is fine for fighting small fires, but is not built for the fighting of structures fires. The new truck will carry 1250 gallons of water and have a pump that will pump much more water then the old

pump. This will really help when we get fire hydrants.

P.S. The bill Chuck spoke of in the above article attempting to eliminate the fire district assistance tax has died in committee.

#### SNOW STORMS

Anyone who has had experience in traveling and exploring the rugged mountains of the western U.S. during the winter season has learned, if he survived, to revere and to respect the calamities that can befall anyone in one of these terrific storms.

History notes the Donner party in 1848 in California where 42 out of 87 perished in ten feet of snow. Hunger and freezing



were the causes. Another example was John Fremont who, not unlike Custer. had his head in the skies instead of on his feet that could have carried him to safety. It is recorded that Fremont with 30 men, horses and mules attempted crossing the San Juan Mountains in southwestern Colorado in the dead of winter. A sudden blizzard forced him to stop as the animals were floundering in the deep snow. It is also recorded that the mules cried like babies before the end. This tragedy should have haunted Fremont the rest of his life. He had had several trips

it made eyesight impossible. The boys bodies were found two weeks later. They had gone the wrong direction.

The Catalina Mountains north of Tucson have been somewhat more fortunate in this regard. A vigilant "search and rescue" group is on call at all times.

In the early twenties the U.S. Forest Service ran a phone line from Tucson via the south slope of the Catalinas to the Palisade Ranger Station and on up to the top of Mount Lemmon. This was useful for the firewatchers in the summer months. They

age and unable to try walking out.

Sometime later Mrs. R. B. discovered the phone outage so she asked for help. Four men drove to Oracle taking snowshoes and a strong sled. On arrival at the store they found themselves on top of eight feet of frozen snow completely covering the little store. When they finally broke in they found R. B. in fair spirits but entirely without food. He was then strapped to the sled and given a ride of his life down the north slope to the cars.

use. The rush was on to play in the snow. Even though Pima County did a fair job in keeping the road open, Curt Guthrie (my carpenter foreman and general handyman) and I purchased a D-6 Dozer for the logging business and also to clear side roads to various cabins.

In 1953 the Mt. Lemmon school opened. By law the county was obligated to keep certain roads opened. In the early sixties the U.S. made plans to erect a radar station atop of Mt. Lemmon. Now numerous construction firms brought in machinery, materials, and

New Mexico. The mountains of Arizona are by no means exempt of these dangers. Only recently two young ladies suffered severe frostbite and lost toes and feet in a stalled car in the mountains near St. John, Arizona, Again, a most tragic end came to two Boy Scouts in the Santa Rita Mountains south and east of Tucson in recent years. As usual, a storm developed almost instantly and these two lads became separated from the rest. The survivors stated how the gale drove sleet and snow into their faces with such force that

installed phone service in four areas; one of which was at R. B. O'Niel's little store in Summerhaven.

As a rule everyone left the mountain for Tucson schools in September. One year R. B. decided to stay on longer as the fall weather was so beautiful. One night late in the fall, a real duzzie of a storm with wind and snow hit the area. The phone line was downed by falling trees and branches. In the morning R. B. found several feet of snow at the front door with no letup on wind and snow. Mr. R. B. was of advanced

workers, some with their families. At once every room, cabin and trailer was rented to workers. If a blizzard came on, a few days shutdown followed.

On December 15, 1962, a real blizzard with winds ranging from 60 to 80 miles an hour came in from the south bringing in a blanket of snow and sleet. This blizzard pelted us without a let up until December 22nd. For a whole week doors were hardly opened, as six feet of snow blanketed Summerhaven. Of course. the winds piled snow in some canvons 15 to 20 feet in depth. At the sawmill the lumber shed was entirely covered. The mill opened up again April 15th. Our post office was entirely covered. On December 22nd Pima County broke through with large equipment to open a one way path.

Where to put the mountains of snow was a big problem. Most of it was pushed off the road. However, through the cuts some D8s had to tow 2 cars at a time as the wind blew in 3 and 4 feet deep in moments. The 16 vehicles in the village and the 30 at the Ranger Station that were marooned finally began their slow crawl to Tucson which required twelve hours.

Only through actual experience can one feel the complete helplessness when disorientation sets in. Often the lost victim will travel in a large circle, but by the time he comes to the place of starting, his mind is so irrational

that he does not even recognize it.

Seems like our winter has been more severe than usual, but the water table and springs have been slow to respond. I keep hoping for more snow.


At a meeting of the water companies' regulatory agencies a cycle of seven years of drier weather was discussed. According to some, we're into the third year of this period. If this is the case, it's going to get worse before it gets better. I'm asking all the Co-op and Forest Service water users to exercise all conservation measures as a matter of course. Expect to be out of water periodically and take precautions before this occurs. Have sufficient drinking water on hand and some extra for a few toilet flushes and cleaning.

#### FIRE PREVENTION TIP

When the snow has melted, rake the weeds and pine needles back from your cabin at least ten feet. It will give us a better chance to save your cabin, if there is a fire nearby.

#### LEASE LAND EXCHANGE

Many of you may have already heard rumblings about a possible land exchange with the Forest Service which would allow many cabin owners on lease land to own the land under their cabin. It's true, however, it's not as simple as it may sound!

Some months ago the Forest Service was approached by David Ulfers about the possibility and they reacted quite favorably. A company in Co Phoenix that has handled many of these exchanges over the years was suggested

and then contacted. Their expertise is invaluable as there are many criteria to be met before the exchange can be finalized.

The simplified procedure is as follows: The affected areas had to be determined first, and it was decided that Loma Linda and Middle Sabino as well as a small tract on the Eastern boundary of Summerhaven where encroachment has occurred would be involved. These are all contiguous and already border private land so no new islands of private land would be created

in the National Forest. Next an appraisal of this parcel must be done as if it were totally undeveloped. Following this a parcel of equal value must be identified that the Forest Service considers more advantageous to own. After several studies required by Federal Law have been accomplished that affected cabin owners would form an organization much like that of a town house or condo owners organization to set their own deed restrictions and rules. These must be done in agreement with the Forest

This is to be done the months of July, August and September.

Service as they are anxious to guarantee that no new cabin sites are created by such an exchange and that all existing undeveloped common areas remain that way. Keep in mind also that there are many County laws which must be adhered to as well as other private concerns. All will be addressed and hopefully satisfied. If this can be accomplished the organization would then purchase the other parcel of land and exchange it for the affected land in Loma Linda and Middle Sabino.



The organization would then deed the appropriate small parcels to each individual cabin owner. Any cabin owner wishing not to participate would have his or her current lease honored by the organization, which would own the land.

As you can see, this is not an easy procedure as there will be many stumbling blocks along the way. Our first step was to see if there was a sufficient number of cabin owners interested enough to proceed. We have had a very strong positive re-

sponse to a survey which was mailed shortly after Christmas and we will now proceed with trying to determine more closely what t cost per owner will be.

A few negative reactions have

occurred to this possible exchange, but only one was by a lease land cabin owner. If this exchange can be completed, it will have a very positive affect on everyone in the Summerhaven area as it will greatly help our tax base and thereby directly aid our fire department! No one, including myself, will receive any commissions of any sort in this transaction except the Phoenix based company F.L.E.X.

## ITS TIME AGAIN! ROAD CLOSURES THIS FALL!!

Starting Labor Day, Federal road construction will commence for the next 3.5 miles.

From 4 Sep to 1 Nov and 17 Dec to 14 Mar the road will be open from 6:30 am to 5:00 or 5:30 pm and 10:00 pm to 11 pm.

From 5 Nov to 13 Dec and 18 Mar to 26 Apr the road will be open from 6:30 am to 8:30 am, 3:30 pr to 5:30 pm, and 10:00 pm to 11:00 pm.

From 29 Apr to 13 Jun the road will be open from 7 am to 11 pm.

From 14 Jun to 2 Sep the road will be open all the time unless the contractor gets behind and has to continue road closures.

It was suggested that the road to Oracle be improved and kept open year around. According to Paul Steinert, Pima County Traffic Engineer, he did not see Pima County plowing the road and Steve Plevel, District Ranger, said the Forest Service will not. Many mothers expressed concerned about how to get to a hospital during an emergency.

The Forest Service is to schedule monthly meetings for continued public input throughout the construction.
