## Many cabins hit as vandals run rampant

Early in September many cabins were viciously vandalized and burglarized by young people from Tucson who seemed to have made at least three separate forays up the mountain. Nearly all cabins were entered in ways the owners had thought were impossible, such as small high bathroom windows, windows with bars widely spaced or by simply prying off security bars that were not well anchored to steel plates on the inside.

A monitored silent alarm system was the downfall of these vandals. Deputy Hartman was dispatched to the cabin where he saw the vandals driving away and radioed for a road block at the base. The vehicle, or vehicles, were stolen in Tucson. After a high speed chase, they were caught at River and First.

Although the case is still under investigation and more arrests are to be made. Det. Pratt of the PCSO said a couple of things have greatly helped on this case. The victims were quick to provide lists of what had been stolen so when the car was stopped the items inside could be

immediately linked to this case giving the authorities reason to hold/charge the vandals. It also made it easy to recover a lot of the stolen property.

An anonymous tip was phoned in to 911 a little earlier in the day (Sept. 4) describing a vehicle and occupants that seemed suspicious and giving a head count of persons occupying it. This description matched the vehicle the authorities stopped.

The amount of damage done to each cabin seemed to be directly proportional to the amount of liquor available inside. Breaking all windows was first priority. In one case the owner's gun was found and used to shoot up the interior and contents. In another a large fire extinguisher was emptied over everything. In many cabins all the food available that wasn't stolen was thrown onto the walls and ceiling a rubbed into the carpeting and furniture. Some furniture was ripped up and urinated upon. Rumor has it the vandals said they did it BECAUSE THEY WERE BORED! Det. Pratt praised deputies Jess Hartman and Ed Hardesty for an outstanding job!

## Fire district gets new insurance rating

During the month of September the Mt. Lemmon Fire Department responded to 24 calls of emergency. The majority of these calls were for medical services.

We have been training in the areas of ladders and driving/pumping of the equipment. We have all completed a national driving course for certification. This course instructs in proper driving skills.

We received a letter from the I.S.O. Commercial Risk Services Inc.. This company rates communities for fire insurance. Mt. Lemmon was a Class 9 before May of this year. We have improved to a Class 7 for commercial and Class 7/8 for residential. The installation of the new fire hydrants in the village and by the Loma Linda tank are the main reason for the change. All commercial property in the village and residential property within 1000 feet of a new large fire hydrant will be effected. You may want to contact your insurance company for new quotes on this new rating. Only the residential and commercial property

within 1000 feet of a large hydrant will receive the new rate of Class 7. All other property will receive a Class 8. This rating effects only companies using the ISO rating schedule. The new rating will become effective on Nov. 1, 1992.

## Bear Canyon area site of several accidents

Milepost 11 seems to be the happening spot lately. The Fire Department has responded to three accident calls at that location near Bear Canyon recently.

A driver lost control of his pickup truck and rolled it several times, landing upright, but with the driver-side door so damaged it had to be forced open to extricate the injured man. He sustained serious injuries and was transported by helicopter to TMC.

Two other accidents both involved motorcycles and riders without helmets. One driver on a large racing type motorcycle took the curve too wide to the right and lost control hitting the rock and rolling twice. His injuries were extensive requiring the helicopter to transport him to the hospital.

In the second accident, a driver lost control of his motorcycle at the same curve, hitting the gravel and rock on the right side and bounced back across the road. Both he and his passenger sustained serious injuries and were moved via helicopter to local hospitals.

The curve about 1/2 mile below Soller's Road has also been hard on a couple of bicyclists. On two different occasions, riders have lost control of their bicycles and sustained injury trying to make the curve. One rider hit the gravel and locked up his front brakes causing him to go over the handlebars. He lost several front teeth and sustained a broken jaw and had to be transported out.

The Fire Department has also responded to several false alarms down around MP 15 at Windy Point for car fires and accidents. Because they have no way of knowing the situation, they must treat every call as an emergency, rushing to get manpower and equipment to the site only to find it has been a hoax.

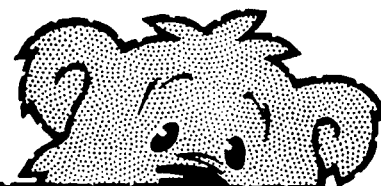

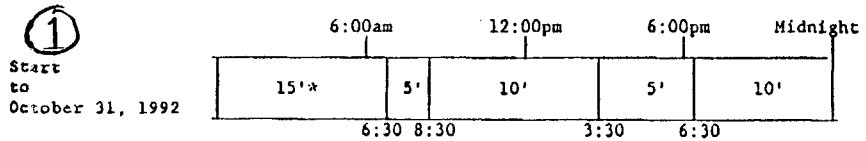

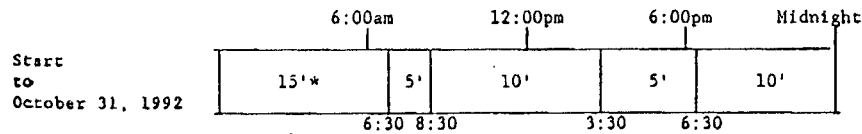

## **UPPER SECTION: Summerhaven - Mt. Bigelow**



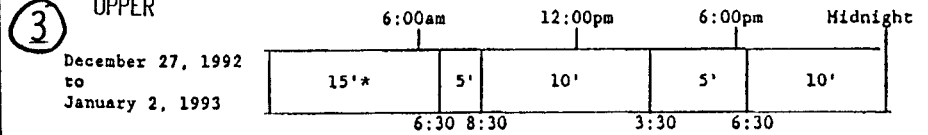
