## Fire Dept. Activity Report

Emergencies have really slowed down for the Fire Department. In February, there were 8 calls (2 vehicle accidents, 4 sled related injuries, and two false calls. March is even slower with only 5 calls (1 vehicle accident, 2 medical emergencies, 1 fall injury, and 1 illegal burn) up to the 25th of the month. The extra time available has allowed the firefighters to increase needed training. There are currently 15 people taking an EMT class at the station. This class started March 6, and will continue until approximately June. Fire personnel are also preparing for the summer forest fire season with special classes in wildland fire behavior and basic incident command. A recent all hands on fire drill seemed very real to a couple of the participants. The live smoke drill in an abandoned water tank resulted in the dispatcher believing the on scene simulated injury was real. An ambulance from Tucson was almost dispatched. Oh well, we try to make the drills as real as possible. On March 7th, new Firefighter Asher Arnold joined the department. Asher and his new wife Jessica moved to the mountain a week later. Asher joins the department with EMT and Forestry Firefighting experience. Please welcome Asher and Jessica to the mountain. Congratulations are in order for Firefighter Dean Barnella, who recently and successfully completed the TMC Intermediate Emergency Medical Technician (IEMT) Course. Dean has taken the National Certification Exams and is currently awaiting the results. It is expected that Dean will be

responding as an IEMT by late April or early May. An IEMT is a step above the EMT and one step below a Paramedic. Mt. Lemmon Fire Department has always provided the EMT service which allows Firefighters to provide basic emergency care. This involves basic life support and oxygen administration with no drug or medicine administration. The IEMT is designed as a trauma specialist utilizing intra-venous (IV) fluids, medications and drugs for trauma victims. Being so remote from the nearest emergency room, the IEMT can push fluids on severe trauma injuries (motor vehicle accidents, falls, etc.) to aid in reducing shock and sustaining the victims life. Dean will be the first IEMT for the Mt. Lemmon Fire Department. Dean's future plans include upgrading from IEMT to Paramedic. This upgrade will allow for the use of additional drugs and medicines for cardiac care.

## BIRDS AND BEES, FLOWERS AND TREES AND ALLIGATORS?!

Have you ever seen an Arizona Alligator Lizard? Me neither until I was raking leaves last fall. Something zipped past my feet and then stopped maybe a yard away. I thought it was a snake because it was about a foot long and quite "snaky" looking, but upon closer inspection I saw it had four tiny feet. It was a golden-brownish color with a darker design that went around its body and it had light pinkish eyes ... with eyelids. I know because I saw it blink. After allowing me to study it for a couple of minutes it vanished into a brushpile.

Not being fond of reptiles, I only own one book about them ... the Audubon Field Guide. This fellow was found in the category of "Skinks and Alligator Lizards". Here's what I learned: It is active during the day. It is a ground dweller (as opposed to a tree climber); it inhabits high dry grasslands or open woods of fir, pine or chaparral from 5,000 to 7,000 feet. While some mountain lizards have live births, this one lays eggs, 9 - 12 at a time, in June and July. Its range is SE Arizona, SW New Mexico and south into Mexico along the Sierra Madre Occidental. It is not poisonous and mostly eats insects.

The Arizona Alligator is either rare on Mt. Lemmon or just hard to spot because in 15 years, this is the first one I've seen and I've not yet found anyone else yet who has seen one.

## OTHER TIDBITS.....

Four fearless adult javelina are permanent residents of the mountain. Watch your children and pets carefully. PLEASE REPORT ALL JAVELINA THREATS OR ATTACKS TO ARIZONA GAME AND FISH @ 628-5376. If they receive enough serious complaints they will remove the javelina from the mountain.

## Refusing Refuse Removal Services ???

The Mt. Lemmon Woman's Club was instrumental in bringing the refuse removal services to the mountain in 1989. They were certain that this would be an asset to Mt. Lemmon and its many visitors. The MLWC wanted a more attractive, esthetically pleasing, litter free village, cleaner picnic areas and a less littered scenic Catalina Highway. There is a problem. The dumpsters for the last 3 years have been located in the center of the village,

next to the public toilet (outhouse). The mini-transfer station (dumpster) was never supposed to be in the heart of the village where 700,000 visitors drive by it. Lets see, if Tucson had a refuse station say, about entrance of Randolph Park on Broadway.... where everyone who drives by could dump their garbage ... how would that look to a visitor of Tucson? That's the problem our community faces on a smaller but still very noticeable scale. The refuse is often overflowing into the street and stream due to this high profile location. The overflow is attracting wildlife and is a danger to the children playing nearby. Patrons of the several of the local restaurants have eating areas within view of this problem. While the county provides this service free to the residents of the mountain, the abuse of the dumpsters by some commercial businesses and visitors has created an outcry from the cabin owners. Most that have been polled would rather see the service pulled if a more protected location outside the village can not be found. The MLWC will have letters for you to sign at the Annual Homeowner's dinner the evening of April 18. They also encourage you to write your opinions and suggestions to improve this situation to:

## SUMMERHAVEN MEMORIES

*Lyle Genung, a long time resident of the mountain, was kind enough to share some of her family history of Mt. Lemmon at the Mt. Lemmon Woman's Club meeting in March. With her permission, we'd like to share her story with you. We'll be printing this over the summer so you'll get an installment with the next several issues. In her own words, this is Lyle Genung's own Summerhaven Memories.*

How many have read Kathy Alexander's book *Paradise Found*? I think you would agree she captures the spirit of the Mt. Lemmon area. It brought many memories back to me and that's when I started putting a story with my mother's Kodak albums. My story takes you up the back or north side of the Catalinas. In 1880 Dr. John Lemmon, a famous botanist from the Lemmon Herbarium of Oakland, CA married Sara Plummer, a librarian, in

Oakland. They planned a honeymoon in Arizona hoping to find new species of plants. In the spring of 1881 the Lemmons arrived in Tucson by train. Passenger service between Los Angeles and Tucson had just recently been completed. The Lemmons tried to climb the Catalina mountains from the south side. After several unsuccessful attempts, they asked about climbing it from the north side. Bob Leatherwood, who was mayor of Tucson at that time, suggested they contact E.O. Stratton who had a mine and a ranch on the north side of the Catalinas above Oracle. (Stratton Mine, "The Pandora") The Lemmons traveled to Oracle by wagon and met a man by the name of Alexander McKay who loaned them a pack burro for their botanical and personal supplies and directed them to the Oracle Ridge trail to the Stratton Ranch. When they approached the Stratton Ranch, E.O. Stratton recalls that John Lemmon was riding the burro and Sara Lemmon was walking. (One of the members of the MLWC remembered reading that John Lemmon had been a prisoner of Andersonville during the Civil War.) The Strattons were glad to see the Lemmons, especially Mrs. Stratton, who hadn't seen a white woman to visit with for 8 months. The next day, Mr. Stratton took the Lemmons further up the Catalina Mountains using his own horses. I have to interject here that until last year, our family thought the E in Mr. Stratton's name stood for Ed. As a kid, growing up that's the only name I'd ever heard of. Then last year Joe Goff, who owns many ranches now

on the north side of the Catalinas and one in Dripping Springs north of Winkleman told us about the reminiscences of Emerson Oliver Stratton. Emerson and our Ed are the same person and we wonder if Ed was a nickname 'cuz how many people do you know named Emerson? While Mr. Stratton and the Lemmons were on the way up into the Catalinas they discovered mule tracks which led to two crude cabins near what is now Summerhaven. In these cabins they found two half starved men who had spent the winter on the mountain. These men were Ira Carter and William Reed who were homesteading 160 acres under the Timber Homestead Act. This area is now part of Summerhaven and E.O. Stratton's book says that Ira Carter's Cabin was located at the mouth of what is now Carter Canyon. Mr. Stratton took the Lemmons to the top of the highest peak in the Santa Catalina mountains and they all carved their initials on a pine tree. Mr. Stratton named that peak Mt. Lemmon (not Lemon) in honor of Sara Lemmon (who was as far as he knew, the first Anglo woman to climb the peak.

In 1897 a trail from Sabino Canyon (Lowell Ranger Station) to Palisades was completed. The purpose of this trail and others that followed was to "encourage summer resorts for the Tucson folks". In September of 1904 the local paper reported that the "Chamberlain and Huntsman families had just returned to town (Tucson) after camping on Mt. Lemmon for the summer". The Huntsman cabin built in 1908 is still

located in the Marshall Gulch area of Summerhaven. It was moved from it's original spot so that a parking and picnic area could be made. In 1905 the Henry Eastman family (as did many of the families) came out to Tucson from Rochester NY for Mr. Eastman's health. He had TB and was put in the Desert Sanitarium (what is now TMC). Mr. Eastman's health did not improve and he died in 1908. Mrs. Eastman had two girls, Alice, 11, and Darthea, 8, and she needed to find some way to support them. Why am I telling you about this family? Because Darthea Eastman was my mother and Mrs. Henry Eastman my Grandmother.

**Woman Slain, Husband missing and his car last seen on Mt. Lemmon highway ...** Yes, you heard it on last Friday's news and read it in last weekend's papers. Pima County Sheriff's Department began the tedious search for the missing man, and I was here alone. Glad to have a Security Placard in my window? You bet. Even more glad to see the familiar faces of the deputies stationed up here checking the neighborhood carefully all Friday afternoon. Nice to have that wave of recognition from the deputies ... and satisfied I took the time to fill out the Security Profile last year and have the Placard in the window where they can see it. Does it help? I think so. The deputies have a reason to become more familiar with the property owners because of the information provided, and the information you give lets them know

whether someone should be in your cabin. At this writing, the husband has not been found, so I'm delighted we have deputies as part of the mountain neighborhood. Fill out that Security Profile Sheet now. Don't chance coming up to an unwelcome surprise.

**Power Outage March 26th**  
Reset those VCR's and clocks. A transformer had to be replaced at Saddlebrook on Sunday according to Trico, so power was out on the mountain for about 3 to 5 hours depending on your location. Other than a much later than normal breakfast, no phone service for a few hours, and no hot showers if you slept in, all was fine by Sunday afternoon.

Also, Trico's board of Directors passed a bylaw amending the assignment of capital credits. The cycle of payment doesn't change (1980 capital credits were returned last year) but the amendment allows members and former members to assign the distribution of their credits to a family member or friend. 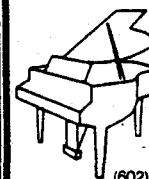

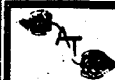

## WATER NEWS

During the next few months the water board, water members, and property owners of Mt. Lemmon will have an **important decision to make**. The water board will be surveying these groups regarding the formation of a **domestic water improvement district**. These surveys will greatly determine whether or not the water coop pursues district formation.

Two and a half years ago I was asked to join the water board. What a great opportunity for me to be part of the solution and not just part of a perceived problem. Since my involvement, I have come to realize that improvements are not only needed but required. We have been granted extensions in complying with some water quality statutes, but time is running out.

The "*minimum*" improvements we seek through district formation are system filtration, additional water storage at Miner's Ridge, and a water transmission line to the Loma Linda tank. The costs for these improvements are estimated to be **\$1.5 to \$1.75 million**. The water company with help from Summerhaven homeowners and MLHO has gained significant legal decisions concerning our domestic water availability this past year. Our water company to remain viable must now proceed with these engineering recommendations to assure water quality and to provide for future growth.

The question therefore, is not what to do, but how to pay for it. Do we wish to pay for improvements strictly through continuing water rate increases, or by selling water district improvement bonds. The water board believes that a domestic water improvement district is the correct route. The board will inform and poll the community through news articles and informational meetings in the near future. These news articles and meetings will impartially portray the pros and cons of district formation. Please remember, we the board, want you to willingly support the district formation processes before any resources are dissipated.
