AZ State TAX CREDIT Form on Cover for Z.E.S.

Along with your Echoes this month you will receive a tax credit form for the Mt. Lemmon Zimmerman Elementary School. If you complete the form, attach a check for up to \$200 and mail to the indicated address before the end of the year you can deduct 100% of the amount of the check from your 1999 Arizona State income taxes. This will get some of your state tax dollars directly to the Mt. Lemmon school without the usual government haircut.

I recommend that you select extracurricular activities and not designate a specific activity. That way the teacher can use the funds for the activities she thinks will be most beneficial to the students. Don't delay, it must be received at Pima County School District office by December 31, 1999 or the state tax credit won't apply to this year.

Mt. Lemmon TRICO GENERATOR Story

Rural electric cooperatives like Trico have a proud history of bringing electricity to remote areas. However, maintaining power quality in areas where lines run through rugged terrain and are battered by winter storms is challenging. Trico is stepping up to meet this challenge on Mt. Lemmon by installing 1500 KW rated diesel engine backup generator.

The site is located near the fire station at the Catalina Highway

and the Mt. Lemmon Control Road. Our work at the site has begun with completion of a new building to house the unit scheduled near the end of November. We hope to have the generator delivered to the site the 1st week of December and to have it available for use by the end of this year.

The generator will enable Trico to utilize its power supply for the Mt. Lemmon area if outages are realized on our existing power lines. Although some areas will still be affected by longer outages because of their location, this unit will be able to provide backup to the vulnerable west slope Trico lines that feed the mountain.

Check The TRICO Livewire for updates. Trico is Y2K ready! Quotes from the Livewire:

"Since the energy source on Mt Lemmon is inaccessible to line trucks and it would be quite costly to totally reconstruct the lines ... the generator would be used to feed power to Mt. Lemmon when trees break the line or when the ice storms cause damage to the line. It could also be used when it is necessary to repair or perform maintenance on parts of the line; essentially becoming the electrical backup for the mountain."

There is a great deal of myth and misconception about Y2K and what it means. First off, Y2K has nothing to do with the millennium. The millennium

takes effect January first, 2001. Y2K takes effect January first, 2000. So what exactly is the dreaded Y2K bug that has so many people nervous?

Many computers and other transactions keep track of the date with a simple mm/dd/yy formula, one that has been in use for a good forty to fifty years. All the driver's licenses, credit cards, and most of the other forms you use have this same method of keeping the date, which is good. Except for that pesky /yy part. Only two digits keep track of year, so what happens when you go from 99 to 100? That question is what the Y2K bug is all about.

Some people think it is going to be the end of the world as we know it, with massive power outages everywhere and planes falling out of the sky. Some people are weirdos. But

Not being Y2K compliant doesn't mean the program will simply stop working at midnight, or that the computer will go on a murderous rampage across the country side, but some functions iust won't work. If you are curious about what programs on vour computer are Y2K compliant, you can find out.

AOL users can use keyword Y2K BUG, and Internet users can go to WWW.CNET.COM and click the 'Y2K' link along the top. Both lead to a wealth of information on the bug and how it may effect all different sectors of the economy. Are you ready for Y2K?

Fire Dept News THIS PAST YEAR - 1999

1999 has been a busy year at the station for projects. As far as emergency calls go, it may be the slowest year of the decade. As of 11-15, there have only been 129 calls. In 1995, there were 299 calls for the year. The slowest total year previously on record is 155 calls. Only December 31st will tell for sure. For the first time in this administration, MLFD went 12 months with no full-time firefighter turnover. However, this changed at the 12-month mark (October) as Mitch Avelar left the mountain. Turnover has typically been 200% per year.

The water storage trailer, at Loma Linda Extension and Florence, was damaged by an anonymous hit and run vehicle. It has been repaired. Plans are in the works to move the trailer to a new location. The installation of Hydrants on Tempe and Loma Linda Extension eliminated the need for the trailer at

this location.

The second floor storage area at the back of the station has been completed. This shelved area now has organized storage.

The upstairs area is almost complete. The area has been converted to a heated training and Fire Board meeting room.

The old Palisades fuel tanks were relocated to the area near the County Highway building. MLFD, Water Coop, Sheriff's, USFS crews and highway department vehicles now share the fuel system.

New Apparatus Building - Called Station 2, was built. This will eliminate having the three rescue vehicles sitting out in the snow and freezing weather. Construction started in February. The building was completed in October.

A second compressed air foam pumper system was added to the 1-ton rescue firefighting truck. We now have two foam fire fighting capable engines.

A Mass Casualty Incident trailer was constructed. This allows the department to keep all extra rescue equipment ready for a major medical incident. In the past, extra gear was stored anywhere we found space for it. If it were needed, it would take time to collect it. The trailer is designed to start work on a 30-casualty incident.

A second computer was purchased for administration purposes. This acts as a back up for all business work. It also gives the firefighters access to certain programs to enhance communications.

1999 generated the longest list of EMT's, Certified Structure Firefighters and Wildland carded firefighters. Unfortunately, the highway construction and normal turnover will reduce the available personnel in the near future.

Three MLFD personnel and one engine responded to the Stanislaus Forest in central California to assist in 16 days of fighting forest fires. The crews gained valuable

experience and training, while the funds generated by the engine assisted in paying off the new building.

A new 4-wheel drive ambulance was purchased in late October to replace the two high maintenance van ambulances. The ambulance came from Edwards Air Force base in California and had prior service on Space Shuttle landings at Edwards. The unit will reduce the department's operating costs and provide adequate space for emergency equipment and multiple patients.

Future Projects include the following:

* Redesign of the Communications
System (Phones, Radio & Dispatch)

- * Implementation of a 24 hour dispatch system.
- * Connecting the Station to a Water System
- * Replacement of Older Pumpers
- * Return to Full-time Paramedic Service

Just a quick reminder - Make sure fireplace ashes are disposed of properly. Ashes dumped into the yard can cause pine needle fires that can burn back to the cabin. Also insure that all furnaces are properly serviced and ready for winter. And make sure that all smoke and carbon monoxide detectors are place and operating.

Water Co-op News & Updates

Ladies and Gentlemen:

SUBJECT: STATUS OF WATER SYSTEM LINE, HYDRANT, AND TANK CONSTRUCTION

The primary purpose of this letter is to update the Summerhaven community on the progress made regarding our 6" transmission line, fire hydrants, and the 212,000-gallon tank installation. We also want to thank all members and associations for their support. Our 6" transmission line from the pump house, located in the village, to Loma

Linda Tank Farm is certified for use. The new fire hydrants are installed and operational and the new tank was erected this month. A low interest loan, wise board decisions, and extraordinary efforts by Ross Quigley and Michael Stanley have made for an under budget project. significant decision, to seek approval for the purchase of heavy equipment in lieu of hiring contractors, has provided equipment for future construction and maintenance and reduced overall project cost. Since our old pump needs replacing, our efforts now turn to a new pump and pump house in upper Sabino to transfer water from the new tank to the Miner's Ridge Tank.

The secondary purpose is to announce a project that will monitor and control the water system in a reliable and efficient way. In doing so we are hopeful to reduce system outages related to the needed transfer of water between storage facilities. While the monitoring of the system itself will not prevent catastrophic system outages, it will notify personnel of a system emergency and will assist in troubleshooting. This benefit could save thousands of gallons of our water. The sooner a leak can be isolated, the less water is lost. Yearly records have shown our system experiences upwards of 32% water loss over the course of a year. This is high but is not unusual considering the mountainous terrain, old distribution lines and freezing conditions. A gallon saved is a gallon we can use. The water board has approved the purchase of a water monitoring system. An outgrown but reliable water monitoring system has become available. This system will be upgraded to provide computer based automated pump control, line flow metering, and system status. Emergency situations will cause a "voice page" to water and fire department personnel. A cooperative effort from the Fire Department has made this radio controlled system possible.

It is the boards primary objective to provide reliable water service while keeping future water rate increases to a minimum. Although we are not charitable association. encourage and welcome donations. Previous individual and organization contributions have provided manv svstem improvements. Since the monitoring systems was not included in this vears budget, any financial support will help offset the \$15,000 system cost. We again thank you for the continued support as we endeavor to provide the community's water If you would like more information regarding the water monitoring system or any other aspect of your water coop, please call me at 743-3034.


