From the President

As I sit here Thursday evening with the scent of smoke lingering from the rattlesnake fire which burns vigorously below Summerhaven, I think of the smoldering that is also going on in this Mt. Lemmon community. This smoldering is not a forest fire but friction between two factions, one in favor of the light festival and the other opposed to its activities. Our heroic fire fighters took care of the fire problem mother nature began with a lightning strike, while those of us in Summerhaven must "snuff-out" dissension before it ignites into something else. We love to come up after a hectic workweek and not have to deal with tensions on the mountain.

Let me begin by again reiterating that the Mt. Lemmon Homeowner's board does not endorse or disapprove of the Mt. Lemmon light festival and it's associated activities. We also have deferred any fire and safety concerns to the Mt. Lemmon Fire District, Pima County Sheriff's Department and the US Forest Service. We (the board) do support the general premise of assisting the local businesses during the highway construction and also provide funds for the Water Coop and the Fire Department. The Mt. Lemmon Homeowner's Association in the past has chosen to report on all community activities including chili cook-offs, art festivals, blue-grass

festivals, Octoberfest, etc. and has never been considered a sponsor of those events because of the coverage they receive.

The Echos newsletter is an "event" paper and is not a public forum for editorializing. It is not the policy of this newsletter to seek controversy or allow political debate or retaliatory articles to be printed. While the organizers could have sought more community support from effected neighbors and businesses, opponents have had months of opportunity to get involved. Let us douse these differences and work together for the better of our Summerhaven community. There is lots of work left for us to complete.

Consider this: More than likely every June until the next millennium comes we will likely have the risk of high fire danger on Mt. Lemmon. We cannot close the mountain to all activities in June because we are fearful of a forest or community fire. Fire danger is a real part of living on this mountain. It is apparent the Forest Service and the Arizona Game and Fish, which take this fire risk seriously has not let this years risk delay their regular programs. Those agencies waived all fees and opened the mountain to all Saturday June 10th.

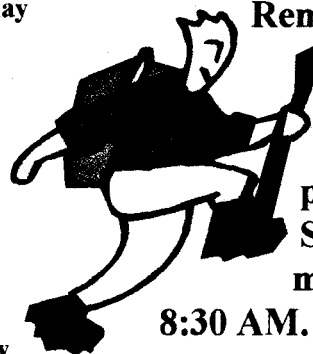
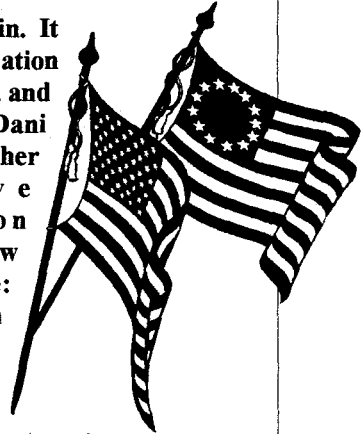
Up coming events:

Fire Dept News

WOW - The monsoons arrived real early. As of this writing, fire season is still being evaluated. The pine needles are damp, but remember they only need one hour (1-hour fuel) to dry out again. The big fire problem this year has been attributed to the 1000 and 10,000-hour fuels. They need 1000 hours and 10,000 hours of moisture respectively to change their moisture contents. These obviously are the large trees. As we are only 3 days into the monsoon season, we will have to wait to see if enough moisture falls to reduce the long-term hazards. In the meantime, continue all safe measures to prevent any fire starts. With the added event of lightning, we have a higher potential for fire starts.



Ash Disposal - Even with the wet conditions, it is still a severe hazard to improperly dispose of fireplace and charcoal ash. Dumping hot ashes on wet needles will cause the needles to dry out and ignite. Ashes can hold their heat for several days. Insure that all the ashes are cold to the touch before disposal.

The Pine Needle dumpster is still here, behind the station. So far this year, we have filled the dumpster 3-1/2 times. We will keep the unit for a little while longer.

Special thanks go to Joan Klinger for her generous donation to the Fire Department. The funds will be used to purchase additional fire breathing air tanks. The tanks will be used to put four additional breathing packs in service.

The air horn evacuation system is almost complete. Some assembly was required. The system is currently going through final component testing and assembly.

One May 22nd, Thanks to Governor Hull, additional funding was available to place additional firefighters on shift. The Severity Shifts run from 9-6 daily. The personnel have been used to continue the operation of the Big Red Pacer burn unit, provide initial attack on any fires (none so far), and assist in updating tactical plans. The shift will continue until the severe conditions end. The following is an excerpt taken from a message to the Chief from a fellow

Alumni. The alumnus was a resident in Los Alamos.

I thought I had seen quite a bit in my years of "hanging" around fire but this is the by far the most impressive damage from fire I've witnessed. The firestorm created put some of these homes (2000-4000 sq ft) completely on the ground in less than 10 minutes with estimated temperatures of 2500 degrees F. A few actually vaporized. There is nothing left but the chimneys and foundations. Some of the earth has vitrified to a depth of 10 inches. On the steeper slopes, the erosion potential is enormous."

Vitrified earth has turned to glass. The dirt is hardened and will no longer sustain life.

Healthy Tree, Healthy Forest, Safe Forest

Chief John Roads, former district ranger Steve Plevel, Forest Service employee Ets Hoken, Arizona State Land Department Fire Management Officer Brian Lauber and Fire Board Chairman Bob Zimmerman recently formed the Forest Health Committee, under the auspices of the Mount Lemmon Fire District, to discuss

chances for survival in a crown fire.

Many Mt. Lemmon homeowners may not understand the critical condition that exists, or its causes. Consequently, education will be the major thrust of this effort, with particular emphasis on the measures needed to reduce the danger of uncontrollable wild land fire. This education will include showing the video, "It's A Matter of Time," publishing a homeowners guide to fire reduction and continuing articles in the Echoes.

Most villagers are accustomed to visualizing the Mt. Lemmon forest as a healthy one, when the opposite is true. Due to lack of regular fires or clearing, it is 1000% overgrown, in many cases with the wrong trees taking over. This compounds the problem of fuel loading and ladder fuels. Conditions have not been healthy for 50 to 60 being.

Members of this committee are planning to delineate critical areas in our community and determine a practical method to reduce fuel loading. However, this will require cooperation from property owners. Raking is essential, but not enough!

Since many people have a negative reaction to the idea of cutting or thinning trees on their property, the committee plans to hold a "before" and "after" demonstration on privately owned lots. This will better illustrate, "clearing or removing ladder fuel to reduce fire danger." Some mistakenly feel that this means wholesale cutting of trees. It does not. However, if this community is to be preserved, some thinning is essential. Thinning forests encourages growth of preferred trees, i.e. those that are more fire resistant, and is beneficial to wildlife.

On Saturday, June 17 at 9 a.m., a talking tour at two sites where trees have been marked to be thinned or removed will take place. The tour starts at Block 6. Attendees may park at the old Inn site and walk a short distance up Turkey Run, just past the first cabin, the Bass cabin. Steve Plevel, Chief Roads and others will explain the fuel reduction process. The second site is Lot 44 in Loma Sabino Pines. Perhaps some could carpool to the second site, although parking is available. It is hoped that many will attend this first meeting, the "Before Phase." Trees will be marked with colors. Green signifies that the tree is to be trimmed, orange that it needs to be watched for future removal. A tree with pink markings is to be removed. This is mainly for diseased trees (beetles and mistletoe) or unhealthy thickets. The borders are generally left undisturbed to preserve visual screening. The committee hopes to organize a crew composed of Department of Correction members and firefighters to do the actual thinning and removal. It is more important to attend the second event, the "After Phase," which will be announced at a later date. Homeowners, who didn't make it Saturday, should at least go by and look at the marked trees, the "Before Phase." Pass the word to as many folks as possible about how this all works. As soon as the work is done, the "After Phase" meeting will be announced. The purpose of all this is to show how to reach a healthy forest condition with the minimum impact. I think you will be pleasantly surprised.

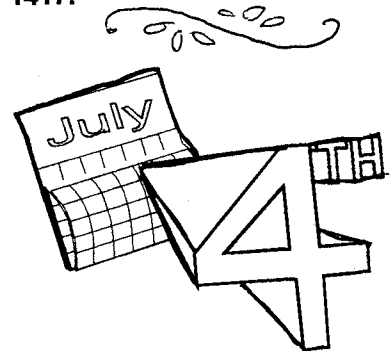
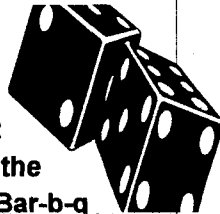

HOW MANY NEEDLES ON A PONDEROSA PINE?

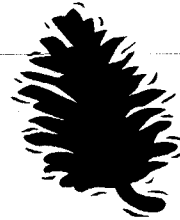

They were devoted Botanists and as such had heard a very strange tale. At that time

"everyone" knew that a proper Ponderosa pine tree had five needles in each "bundle" on the tree. The botanists had heard a rumor that in Arizona, on top of a mountain, there were Ponderosa pine trees with only three needles to a bundle. Now because they were so devoted to their profession, they came to investigate. We all know the story of how Sara was the first non-Indian woman to reach the top of the mountain and have her name given to the mountain for all time. Did they find the three needled pines? Yes, and if you have three needled pines and five needled pines, you are sure to find a few with four needles. 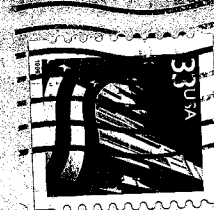
