This past month we had water leaks of 20 and 50 thousand gallons. The leaks were caused by residents who did not properly winterizing their cabins and forgot to turn off the water at their meter before they left the mountain. If you would like some winterization suggestions don't hesitate to give you company a call. Our best suggestion is turn the water off at your meter before you leave and be alert for leaks when you turn the water back on when you return. ### M. L. FIRE DISTRICT "BUILDING A FIREWISE COMMUNITY"

**FIREWISE COMMUNITIES** - What is it? A national effort to reduce the losses to homes in Wildland fires. Los Alamos Fire Department and the surrounding agencies have been working for 4 years on the FIREWISE effort and still lost over 230 residential structures. In the next year, you

will see a FIREWISE COMMUNITIES national marketing effort including TV commercials with famous people who have lost their homes in Wildland fires. The basis of the FIREWISE COMMUNITIES is one (1) goal - To have the Community and Homes survive a Wildland fire without the intervention of the fire fighting forces. We cannot make a goal to not have fires, as there are so many variables to fire ignitions. For the last several years, Mt. Lemmon has been very LUCKY on the lack of fire starts in and around the community. It cannot be our goal to extinguish all fires. It takes 6-10 firefighters minimum for each structure fire. Mt. Lemmon employs 3 firefighters at a time. With 75 mile/hour winds, more than 230 homes were on fire in one evening in Los Alamos. You do the math. We must make it our goal to withstand the fire.

I just recently attended two Wildland/urban interface seminars and learned some amazing facts. First, a Wildland/urban interface hazard is defined as a condition where Wildland natural combustible fuels touch man-made constructed combustible fuels. For example, a tree growing through a deck, a village built in the forest, etc. In viewing photos of all the major structure loss fires, it is evident that the forest fires did not burn the homes as we think. Almost all the destroyed homes are still surrounded by green trees. The trees are not burning. Only the homes are burning. There is not a major wall of flames (crown fire) coming from the forests into the residential

areas as was previously suspected. What is actually occurring is that forest is throwing firebrands ahead of the fire. As the forest fire approaches the homes, it runs shy of trees and crowns and drops to the ground as a surface fire. The firebrands and surface fire are what are causing the homes to burn. As one home catches fire, it throws additional firebrands to the next home. The fire brands from the forest and from the burning homes set additional surface fires which can also ignite homes if the surface fuels touch combustible homes. This process turned into a vicious cycle in Los Alamos.

We have been advocating clearing a space around the cabins for a defensible space. This space also stops a surface fire from touching and igniting the cabins. In Los Alamos many homes were saved by this simple clearing of fuels away from the home. Some homes in areas remote from the surface fires burned when firebrands ignited pine needles and leaves in the gutters, on the roofs and left on the ground touching the combustible home construction.

Why are homes catching fire from firebrands? There are many variables here and it is impossible to say exactly, as not too many firefighters want to actually stay in the area to watch the process. As stated above, many may be due to the combustible litter on and surrounding the structure. Another cause is vinyl materials being used



as siding and especially in the eave vents. Vinyl melts rapidly and allows firebrands to directly enter the structure. This was a major factor in Florida. Firebrands landing in woodpiles that are located too close to a cabin is another factor. The woodpile produces enough long-term heat to ignite a structure. Firebrands landing underneath the cabin is another major factor. In some areas, nearby flammable vegetation can ignite a structure and the nearby heat can easily fracture single pane glass. Once the glass breaks, the fire has instant access to the structure interior. Double paned glass is more resistant to fire heat. Why are COMMUNITIES striving to become FIREWISE? Well, most are involved because they experienced a WAKE UP CALL that motivated the communities. The wake-up calls have included fires threatening the communities as well as fires entering the communities. Other communities are aware enough of their present conditions and dangers and are striving for improvements before their wake up calls. Mt. Lemmon has not yet had its wake up call. I hope we can move forward without one.

So what do we do? We embark on a long-range plan to educate, communicate, participate, contemplate, demonstrate, advocate, activate, motivate, and cooperate. MLFD recently applied for two separate grants. Both are part of the national \$1.7 billion that was allocated after the Los Alamos fire. One grant is designed for hazard analysis of both fuels and structures coupled with education. The second grant was designed for actual thinning projects within the village. The grants are only a start. They cover events that have to occur before next September. Obviously we will need additional projects and funding after this, but it is a start. The Mt. Lemmon Fire District is committed to providing education,

data, and guidance to move forward. Our new motto is Mt. Lemmon Fire District – building a FIREWISE COMMUNITY. This will require efforts on all the residents and owners of the community. As the late President John F. Kennedy once said – “There are risks and costs to a program of action, but they are far less than the long range costs of comfortable inactions”.

#### PREVENTION WARNINGS

With the cold weather setting in, it is important to insure that all heating appliances are properly serviced, that there are proper methods of ash disposal (remember, ash piles can retain heat for several days that can ignite adjacent combustibles), and insure that all smoke and CO detectors are in proper working order. Be sure to inspect your propane-powered heaters to ensure that there are no leaks. Keep all portable heaters away from combustible materials such as curtains, clothing, furniture, etc.

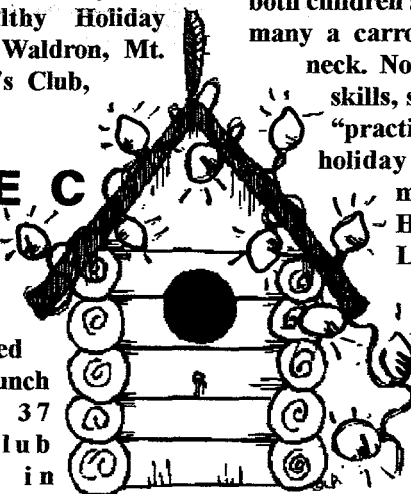
## MLCEC HIGH LIGHTS

## Thoughts on the School Tax credit.

In 1999 many mountain residents made tax credit contributions to the Pima Accommodation District (around \$4,000) specifying that those funds be used for the Zimmerman Elementary School. Well it appears that the Pima Accommodation District, which is operated by Pima County School Superintendent's office, has made some very strict interpretations of the Arizona Revised Statue that controls the use of the money. I have been told that practically every request by the school for the use of the money has been denied. It seems like these bureaucrats have other plans for our money, which apparently does not include the Zimmerman Elementary School. This year I plan to make my tax credit contribution to another school whose district office makes a broader interpretation of the statue and allows my money to get to place I intended. - Chuck Autrey

*editor's note: tax payers are able to get a credit for contributions to Public and Private Schools on the 2000 Arizona Tax Return. For public schools you can deduct up to \$200 and for private schools the limit is \$500. You can give \$200 to a public and \$500 to a private school for a total of \$700. ## "Bear Aversion Conditioning"

Recently there have been many reports in the state and local newspapers about bear sightings in the cities and towns. The reason for this unusual influx of bears is reported to be the long dry season that virtually eliminated their food supply in the higher reaches of the mountain ranges.

Arizona Game and Fish's answer to the problem has run the gamut from relocating the offending bears to killing them. There probably have been more killed than relocated. Other states have taken a different approach, which has been good for the bears and good for humans. Bear biologist Carrie Hunt uses three Karelian dogs, born with an instinct for handling bears safely to teach the bears to leave people alone. They are used in conjunction with traditional aversion-conditioning tools such as beanbag rounds and pepper spray. Hunt, who has spent 20 years as a bear biologist with government and private agencies in Montana, Wyoming, New Mexico and Canada, said, "The trouble with simply relocating nuisance bears is that too many return and have to be shot. We don't just teach them fear of people; we make it clear that if they walk away, they'll be left alone." The Karelian bear dogs work the bears on the ground like cattle, herding them away from populated areas. The strategy is to provide long-term solutions for reducing conflicts by working with a bear's mind to teach it "no". It is obvious that the humans haven't learned not to put out feed for the bears so maybe the bears could learn a little faster to leave humans alone. It would be interesting to see of our local Game and Fish authorities



would explore this alternative if the bears become a problem again next year. It would take a little effort but it would be much better than euthanizing. - Carrie Reitz

## George P. Davies Generating Station Dedicated November 3

On November 3, Trico and AEPCO staff were joined by members of the Mt. Lemmon community to dedicate the cooperative's back-up generator to George P. Davies. Davies, owner of Mt. Lemmon Ski Valley, was honored for his 25 years of dedicated service on the Trico Board of Directors and for his leadership as its president for the past 21 years. Around 60 people were present at the dedication and ribbon cutting and at the reception that followed at the Mt. Lemmon Fire Station. "We were truly pleased with the community's response to and participation in the event," says Marv Athey, Trico's general manager. In the past, extended power outages were not unusual on Mt. Lemmon. Difficult terrain and adverse weather conditions often hampered Trico crews' efforts to make repairs and to get power flowing to the mountain's 700 residents. Trico has now met the challenge of providing reliable power to this remote part of its service territory by installing a 1,450 kilowatt diesel backup generator on the mountain. It can be turned on remotely from the Ina Road office if weather makes the road to the mountain impassable. There is enough fuel to keep the power flowing for a week without replenishing supplies.

## Ski Valley News

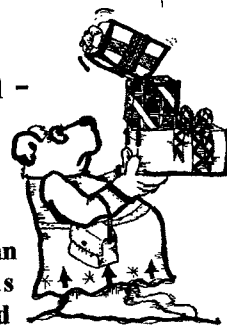

## Septic Update

*Special thanks to Tom Farley, VP Government Affairs, Arizona Association of REALTORS for the following informational update:*

The following is a brief summary of the hearing regarding the On-site wastewater proposed rule package as drafted by the Arizona Department of Quality on December 5, 2000:

The Governor's Regulatory Review Council (GRRC) held a hearing on the Arizona Dept. of Environmental Quality's Onsite Wastewater Treatment Facility proposed rule package. Testimony by the public lasted about three hours.

The Governor's Regulatory Review


Council passed most of the package minus the provisions regarding nitrogen management (R18-9-A312 [F]). The entire proposed rule package is approximately 112 pages. R18-9-A312 [F] dealt with nitrogen loading and minimum lot size for on-site wastewater treatment facilities (lots less than one-acre).

To put it simply, what did pass GRRC could best be summarized as a continuation of "Bulletin 12" requirements for on-site waste water treatment facilities. The new rules as it pertains to the permitting process won't go into effect until Jan. 1, 2001.

The Arizona Assoc. of Realtors and the Arizona Dept. of Environmental Quality will be meeting after the first of the year to discuss the inspection of on-site waste water systems and nitrogen management of on-site wastewater systems. The overall picture is that the rule package proposed by ADEQ was a little too broad and would require "fixes" to problems that are not evident in all parts of the state. AAR and ADEQ agreed to rewrite the problematic portion of the rules package and submit it sometime next year.

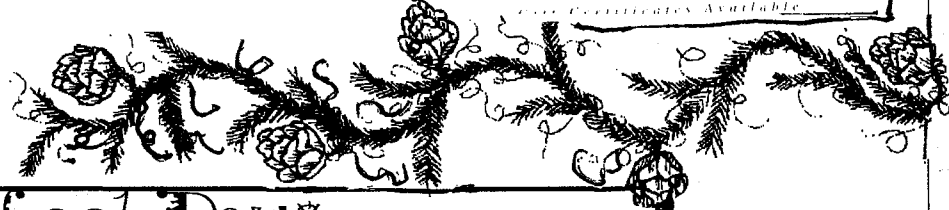

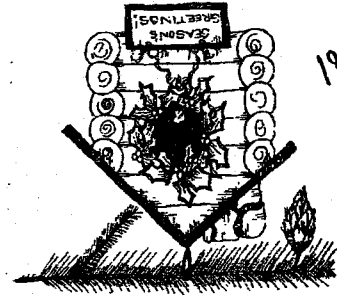

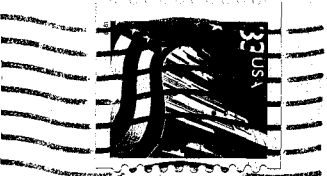
