THE COMMITTEE FOR BUILDING A FIREWISE COMMUNITY

by Chief John Raods The FIREWISE Community effort is underway. In the last month, a community committee was established to further the goals of the national FIREWISE Community effort on Mt. Lemmon. The committee consists of local community representatives meets to further the FIREWISE education on the Mt. Lemmon. The committee is currently made representatives of the Fire District, the business community and interested homeowners. Efforts are underway to recruit and include representation from every Mt. Lemmon organization. The committee has several goals ranging from short-term immediate educational goals, medium range educational goals and long range planning.

The first and most immediate goal was to develop a one-weekend do-it-yourself fire hazard reduction flier (included in this issue of the newsletter). The next range projects include furthering the efforts of the "Matter of Time" Video (available for free check-out at the Congrel Store) and

the General Store) and developing a shorter, CD version of the video; assisting the Fire District in the implementation of the awarded grants programs (see below); developing further hazard reduction test properties; developing a Mt. Lemmon FIREWISE web (www.mtlemmonfire.org); and developing further educational materials based on local conditions, including a basic fire safety brochure that will address fire extinguishers, smoke detectors, proper ash disposal, village evacuation tips and more. This committee is a communitybased committee designed to benefit the entire Mt. Lemmon community. This committee is not limited to any specific mountain

homeowner or business area

(private and leased properties are included). Your input is requested and encouraged. We especially want at least one representative from each Mt. Lemmon organization to insure that adequate communications is maintained for all members of the community. To learn more, or to join in on the committee activity, contact either the Committee Chair Person - Judy Epstein (760-2802) or the Mt. Lemmon Fire Chief - John Roads (576-1201).

FIRE GRANT AWARDS

Three fire grants have been awarded to the Mt. Lemmon area to aid in fire hazard reduction efforts. One grant was awarded to the Loma-Sabino Homeowners Association and the other two were awarded to the Mt. Lemmon Fire District. The LSHO grant was awarded for thinning projects. One Fire District grant was awarded to do a combination of a detailed hazard analysis of both natural and manmade fuel loading, development of educational materials including comprehensive homeowners guidebook that will be designed to educate all homeowners and residents of the Mt. Lemmon fire conditions. The second Fire District grant was also awarded for thinning projects in the Summerhaven area. All grants are awarded through the Arizona State Land Department and will be enacted in conjunction with each other. More information will be forthcoming as the grant programs are initiated.

SUMMERTIME TIP

The mountaintop is quite busy with visitors and friends. We must be alert for any accidental fire starts including improper disposal of charcoal and fire place ashes as well as discarded smoking materials. There is a book written about Mt. Lemmon called *Paradise Found*. For me, it is just that. I love being up at our cabin! I imagine it is the same for many of you as well—that is why I am taking an active role in protecting my emotional and financial investment in our mountain community, and ask you to consider doing the same.

Last summer I watched a fire educational video, A Matter of Time. Truthfully, the beginning

To this aim, a growing number of concerned residents people have formed the Committee for Building a Firewise Community, and I have been designated Chairperson. Those involved to date include: Fire Chief John

Roads, Bob Zimmerman, DeAnna Barnella, Kelly Shanahan, Steve Hensel, Karen Brewer, Larry Waldron, Ross Quigley, Kathy Shields and a special guest, Ed Brunson from the Nature Conservancy.

A FireWISE (Will It Survive Embers?) Flyer was created, a copy of which is contained within this issue and other copies will also be available at local business locations. This checklist identifies projects that better safeguard you and your family, your property, and our Mt. Lemmon community. A shorter version of the video, A Matter of Time, was edited to highlight key points pertinent to us. This version has been

previewed by several people who said they found it informative. extremely helpful, and motivating. Afterwards they were especially eager to go through the FireWise Flyer checklist and see what improvements they could make! This edited version will viewable on a CD-ROM soon. Copies will available to be checkout for your free individual viewing at the Mt. Lemmon General Store. A group viewing is also scheduled immediately following the June 30th Water Board meeting at the Fire Station. Hopefully soon, we will also have it back in the VHS format for individual viewing as well.

I spoke with Robert Hooker, someone very involved in making the video originally. He will look over my editing and, if approved with Ron Moody, will make the same edited copy from the master digital copy for free, and provide us with a video tape and CD ROM copy that we can make copies from..

Septic Systems

Update by Bob Zimmerman

After writing to all political persons in the state regarding the

dire consequences of the Septic System Rules that was passed by our Governor, I was asked to serve on committee formed by Pima County Department of Environmental Quality. One of the purposes is to determine the affect of the new rules on Mt. Lemmon. In my letter, I claimed that the new septic rules would shut down Mt. Lemmon.

The original draft of the proposed rules included changes to the installation of septic systems (making old rules tougher) and introduced a new concept which involves control of nitrogen in the effluent. Nitrogen control will require filters and/or other techniques to reduce nitrogen in the effluent and the process will be expensive and ongoing. The nitrogen control concept was stripped from the rules adopted in January, 2000.

However, at the last meeting we learned from the state that the nitrogen rules are coming back and are expected to be adopted around January, 2001.

I still feel that the combined affect of the adopted rules and new nitrogen rules will 1.) eliminate many lots on Mt. Lemmon from qualifying for septic systems and 2.) prove to be too expensive for those that can squeak by the new rules.

The county has agreed to conduct several test installations on Mt. Lemmon which are in the process of being arranged. In my opinion, if you own a lot, I would attempt to get a septic system installed before January.

At the last meeting I asked the question what is to happen if a good portion of the remaining lots cannot accept septic system or it is too expensive under the new rules. I suggest that this would constitute a "taking" in which the responsible agency would be called upon to

reimburse the owner at fair market value before the rules went into effect. This would require a successful class action lawsuit.

I asked that they be prepared to offer alternatives to the many tax payers who own lots on Mt. Lemmon on which ever increasing real property taxes have been paid for the past 60 years.

ACROBATS IN THE FOREST

As I sat on my deck last weekend, pretending to read, I thought how lucky we are to have such a beautiful forest to share with the animals and birds that live here. The broadtail hummingbirds were buzzing around the feeders and flashing their red throats and diving with a whirring of their wings. Before the next ECHO'S is out the Rufous will be back for their short stay on their way to points South. There have only been a few Blackheaded

Grossbeaks and Pine siskins around so far. Someone told me they had found several Junco nests under their decks.

What I was most intrigued with were the antics of several squirrels that were visiting my feeders. One would run across the railing and grab a sunflower seed and scurry back up the tree to eat. As they got used to me they became bolder, and would sit on the feeder One had a while they ate. beautiful tail and had lost all the ear tuffs, but there was one that was so skinny and had a very thin tail and still had the ear tassels. He would run up on the roof and peer down over the edge to make sure nothing was a danger to him then dash to the feeder to eat.

These are the Abert squirrels and are considered the most beautiful of all squirrels. They are also known as Tassel-eared squirrels. They are very specialized as they only build their nests in the Ponderosa pines that are their main food supply. You remember they eat the pine cones just like an ear of corn. There have been several studies of them done in Colorado. They have found the nests are built of twigs and are near the trunk on the southeast side of the tree. I wonder if this direction holds true in Arizona. The nests are in the upper onethird of the canopy. They breed from February to June and have two or three babies depending on the availability of food at the time of breeding. This means the survival is dependent on the food supply after the babies leave the nest and may not be the same as during the period when they were breeding.

Have you ever seen the squirrels hanging by their back legs and drinking from the hummingbird feeder? The way they jump from tree to tree through the canopy is They truly are little amazing. acrobats.

Just a reminder, humans and cabins and the village are not the only ones to suffer if ever we had a fire in the forest.






