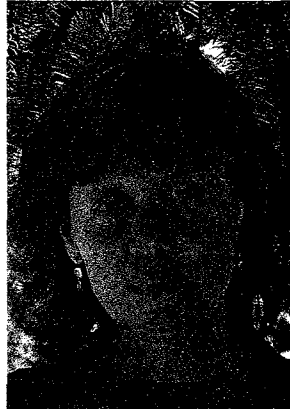

## Fuels Management Projects

Holliday Timber Products has begun to haul timber from the Miner's Ridge/Carter Canyon locations

- This project started on April 28<sup>th</sup>, 2004
- The 1<sup>st</sup> phase of this project is to cut and remove trees from National Forest Lands under permit to the Mt. Lemmon Co-Op Water for areas surrounding their water systems/tanks
- The Coronado National Forest has *not* given permits to have trees removed for their Lands adjacent to or surrounding individual properties
- The Coronado National Forest is in the process of conducting a Timber Sale (4 separate sales – tentative locations as follows)
  - Red Ridge – Canada del Oro – (CDO)
  - Steward Observatory areas
  - Carter Canyon perimeter
  - Fern Ridge areas
- Holliday Timber is *only* removing "marketable" timber
- The limbs from those trees and any slash/debris will be removed by organized Volunteer group efforts, if/when possible
- Any remaining "unmarketable" timber will be the responsibility of the individual Property owners.
- The individual Property owners will be contacted if there is a concern with utilities/structures impeding this procedure

The Mt. Lemmon Fire District is assisting in support of this project and the Property owner's efforts

- The Mt. Lemmon Fire District is in receipt of an Air

**Curtain Destructor – (ACD)**

- This unit is the size of a 40-yard dumpster and has the capabilities of burning up to 6-tons per hour of slash/debris
- The Mt. Lemmon Fire District has qualified sawyers on staff to assist with fuels treatment and the FireWise efforts for the Property owners
- The Mt. Lemmon Fire District has leased heavy equipment to assist with these projects
- There is a requested donation to assist with the costs of the manpower and equipment needed to provide fuels treatment on individual properties
- For all access to properties, there is a **Liability Release** form available at the Fire Station that must be signed and on file
- First priority for fuel treatment is in the Miner's Ridge/Carter Canyon locations
- Second priority will be lots that are in the process of construction

**Fire Restrictions on the Coronado National Forest...**

according to a news release effective at 8:00 a.m., Friday May 28<sup>th</sup> include:

- **Open Campfire Restrictions:** Any open fire, such as a campfire or charcoal grill, is **prohibited** on National Forest system lands, **except** in Forest Service-developed campgrounds and picnic grounds where grills are provided. Pressurized liquid or gas stoves, lanterns, and heaters meeting safety specifications **are allowed** both within and outside developed campgrounds. Simply put, if the heat source can be "turned off" it is permitted outside a developed campground.
- **Smoking Restrictions:** Smoking is only allowed within a closed vehicle, within a building, or within a developed recreation site and while stationary in area at least 3 feet in diameter, free and **clear** of all flammable material. Smoking is **prohibited** while hiking, riding, or visiting any other areas not described above.
- **Fireworks:** Fireworks are prohibited on all National Forest system lands year-round.
- The year-round campfire permit system on the Santa Catalina Ranger District, including Mt. Lemmon and Redington Pass, will be suspended during fire restrictions.

The Mt. Lemmon Fire District posted this latest News Release at the local businesses and Post Office in Summerhaven. We are all hoping for a safer summer, with fire response **OUTSIDE** of our Community!

**What is the Mt. Lemmon Fire District doing to prepare for the upcoming fire season?**

The Arizona State Land Department has provided funding to the Mt. Lemmon Fire District to add 1 additional firefighter on duty for an 8-hour shift, 7 days per week until monsoons to assist with the Initial Attack of any Wildland fire. This staff member will also assist with the FireWise projects and Air Curtain Destructor operations.

**Fuels Management Update**

The Mt Lemmon Fire District (MLFD), in cooperation with Pima County (PC) and the US Forest Service (USFS), is planning to remove dead standing trees on private and public lands that pose a hazard to existing and planned cabins, public facilities and roadways. An agreement has been made with the Holliday Timber Products Company of Edgewood, New Mexico to work under the authority of the MLFD to cut standing dead trees and transport the marketable ones to Tucson. Holliday started working in Carter Canyon on National Forest Lands (NFL) on April 28. MLFD is working with PC to execute an Intergovernmental Agreement (IGA) in early June so that Holliday may proceed to PC right of ways and private properties. The general plan is to complete one area (PC right of way, NFL, and private lots) before moving to another so that the crews do not have to return.

In order for trees to be cut and removed from your property, you must sign and mail (P.O. Box 759, Mt. Lemmon, AZ 85619), drop off or fax (576-3095) a "Liability Release Form" to the MLFD. Please sign and return these forms as soon as possible. It is requested that those cabin owners who are rebuilding this summer contact your neighbors and urge them to participate. There have been 337 Liability Release Forms executed as of 05/27/04. If you do not have the form, contact MLFD at 576-1201 and they will fax, e-mail, or snail mail you one.

It is estimated that about half of the dead trees have already been removed from the private land. There are standing dead trees remaining in areas where cabins did not burn. This offer also applies to these trees. Mark the trees that you want cut and removed from your property with a white "X". If there are dead trees that you do not want cut then mark them "SAVE"

There may be some trees that are too close to a power line or existing cabin to cut safely. You will be advised of any problem trees on your property. In the event a tree marked "SAVE" is accidentally knocked down by a falling tree it will

be left on the property. The logging company will remove all other cut trees. If you have cut trees lying on your property and want them removed mark a white "X" on the end of the log. After the trees are removed, arrangements will be made to collect the slash from your property for disposal.

The MLFD offers a comprehensive program for fuels treatment on your property. This program will trim the live trees and remove dead trees on your property to ensure that it is "Fire Wise." A donation to assist with expenses is requested for this program. Contact Deanna Barnella @ 576-1201. If you are planning on rebuilding this year, you should contact Harry Findysz or Dean Barnella at the MLFD for a Fire Hazard Severity Rating for your property. The Fire Hazard Severity Rating must be attached to your plans for submittal to PC Development Services. The MLFD phone number is 576-1201. There have been 136 new Fire Hazard Severity Ratings completed as of 05/27/04.

All parties involved in the tree removal project have assigned their interests directly or indirectly over to MLFD so that only one agency has control over the entire process. Access to areas where sawyers are active will be extremely limited in the interest of safety and orderly process. This may include every other weekend. PCSO will closely monitor the situation. MLFD thanks the community for their support of this project.

He received his Bachelor's Degree from Gorham State Teacher's College (ME) in 1947, after serving in WWII with the 625th Armored Infantry Battalion. Phil saw action in France, Belgium and German, the most difficult period being the Battle of the Bulge. Phil married Nancy Goodwin, January 19, 1946, Winchester, MA. By going back to New England each summer, Phil earned his Master's Degree at Boston U. In

1953. In 1972, he received his Ph.D. from U of A.

After retiring from teaching, Phil and Nancy moved to Mount Lemmon, so Phil could concentrate on his outstanding watercolor painting. Phil was a member of The Southern Arizona Watercolor Guild and served on boards for Mount Lemmon Fire District, KUAT-TV Public Advisory, and Parkinson's Foundation.

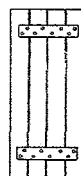
out, growing conifers is quite a science. Hopefully I will have pictures as they grow so you can see their progress.

### Tree Planting Education Classes

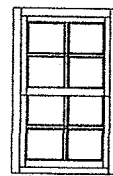

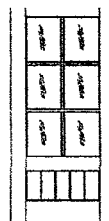

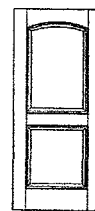

## Water Co Op/District

The rebuilding of the community is in full progress. There are about 25 or 30 places going up. Foundations are emerging from the cleared sites and structures are rising up.

The Co-op will have a membership meeting on 7/3/04 at 10:00 at the Mt. Lemmon Fire Station. We will be sending out a Member's notice and mail-in-ballots on 6/8/2004. The Board of Directors has setup two ways to vote on the transfer of the Co-op assets to the District. You will be able to vote via the mail-in-ballot or attend the 7/3 meeting and cast your vote there.

The Water Infrastructure Authority of Arizona (WIFA) is prepared to loan the District \$1,050,000 to pay off the Co-op's existing loans and provide construction funds to install the Sabino and Carter Canyon improvements. This will enable the District to prepare for the building of the homes lost in the Aspen Fire. We are also in the process of asking FEMA for the installation of a 6" main line from the Carter Canyon System to the Upper Goat Hill area for fire support.

Spring has brought a new outlook to the Village. The rebuilding is wonderful to see and the Mt. Lemmon General Store is a beautiful building that will provide continuity to our mountain. I hope to see everyone at the Aspen Ball, at the grand opening of the store, at the festivities during the first anniversary of the Aspen Fire and at the 4<sup>th</sup> of July Parade.

Your water company is working to provide water to all service locations in our area. As you are aware we are in the midst of a prolong drought that may continue for an undetermined time. We have sufficient water to allow firefighting support but PLEASE be extremely careful with FIRE.

### Sale of the Water Co-op

We are completing the last items required for the Water District to assume the Water Co-op assets. This will require a membership meeting with Co-op members approving the sale of Co-op assets to the Water District.

Co-op members will be notified by mail at least 10 days before the membership meeting. The mailing will include absentee ballots with stamped return envelopes so we can obtain the needed votes to sell the Co-op assets.

Our thought at this time is to have the General Membership meeting on the mountain **Saturday, July 3rd at 10:00 am at the Fire Station**. We would like to encourage the use of the absentee ballot prior to the meeting in order to simplify the process.

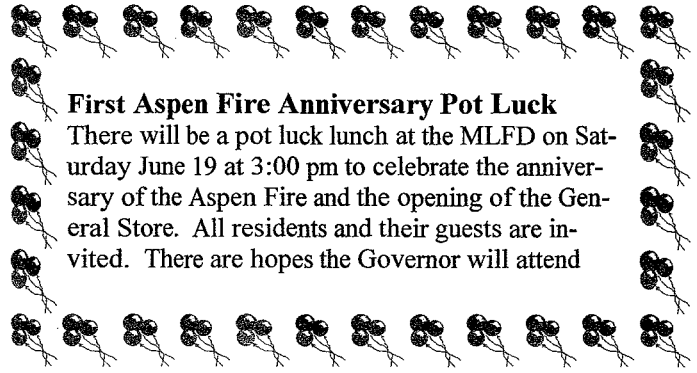

## IN MY BACK YARD

Yesterday the Gamble quail babies hatched. I saw them right outside my window as the mama was taking them to another place. I'm guessing under the rosemary bush but I don't know for sure. There were at least six or seven tiny balls of feathers tumbling around on the sidewalk. The parent quail always moves the babies as soon as they hatch. I've had nests in hanging baskets and she just pushes them out of the basket and after all are hatched she takes off with the brood. Both parents help raise the little ones, who do not have a great survival rate. I heard of a round tailed ground squirrel coming out and eating one of the baby quail. I thought ground squirrels ate mainly seeds and grasses and berries but they also will eat other ground squirrels that have been run over on the road. Mother Nature is not kind!!!

While we were on vacation for 11 days we thought we would check the cars, and both had pack rat nests in them. In the truck the nest was about 6 inches across and I thought it might be a bird nest until we saw bits of wire in it. Usually pack rats (or wood rats) live underground in very elaborate tunnels. They pile cholla around most of the entrances and other things such as Kleenex, foil, and sticks and twigs. I saw a snake go into one of the holes of a nest and the pack rats came out every exit. It was quite a sight. the snake going in and out of the holes and the rats trying to keep ahead of him.

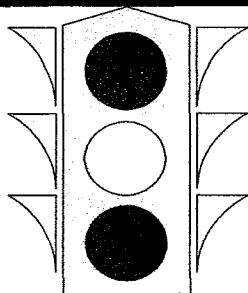
The Lesser Goldfinches have lost their bright colors but the Cardinal and Pyrrhuloxia still add color to the skies.

**Mt. Lemmon Highway****Reconstruction**

The seventh and final phase of the Federal Highway Administrations (FHWA) reconstruction of the Mount Lemmon Highway is currently underway. The widening and safety improvements project will reconstruct the highway between milepost 11.2 and 15.9 (Cypress Picnic Area to Lizard Rock). Improvements will include a wider and safer roadway, improved drainage, new roadside pullouts for slower traffic and temporary parking, new vista areas, including a redesigned facility at Windy Point Vista, will provide safer pedestrian access and a larger parking area.

The work operation of shoring and wall crews at the Windy Point Vista, originally scheduled to be complete by Memorial Day, has been extended. Restrictions currently in place to insure the safety of the public will remain in effect. These include the closure of the area to all vehicles and pedestrians, including hikers, rock climbers and bicyclists. Additionally, no parking of any type will be allowed in the area until the Vista is opened.

Due to the limited site distance and the "alternate-one-way" passage areas in the work zone, the use of a traffic control signal will remain in effect in order to move vehicles safely through the work zone. The delay at the traffic control signal should not exceed 10 minutes.
