## Summerhaven Village Center - John Jones

Planning for the new Summerhaven Village Center commenced with the submission of the master plan and design guidelines to the the Pima County Design Review committee. The committee will meet on March 17 to review the proposal. The application package is available for review at Mt Lemmon

Realty. A new Lodge will be constructed on the site of the former Alpine Lodge. A new restaurant, retail spaces and 16 hotel rooms will be located on the site. An outdoor patio/deck will overlook Sabino Creek and Sabino Canyon

Parkway. Starting in April, a community design process will determine the design, uses and functions of the community center. Subsequent construction will include a restaurant, retail shops and residences. Using the concepts developed by the University of Arizona College of Landscape Architecture, the restoration of Sabino Creek will be a focus for the development. A trail on the east side of Sabino Canyon Parkway and additional parking will also be constructed.

Phil Swaim and Todd Roberts of Swaim and Associates, AIA are the architect and Bob Suarez and Phil Salazar of RS Engineering are the civil engineers.

A second public hearing on the conditional use permit is scheduled for April 13. The Board of Supervisor meeting for final approval is planned for May 17. The project is being developed by Bob Zimmerman, John Jones, Lew Lindley and Michael Diesenhouse.

A display and information about the project will be made at the Homeowner's

Association meeting on April 19.

# YOU MAY PERMANENTLY LOSE THE CLAIM RIGHTS JUNE 19<sup>TH</sup>, 2005

In Arizona, there is a two-year limitation period; so if they do nothing further, they may have no recourse against their insurance company after June 19<sup>th</sup>, 2005.
