




# Harry J. Findysz

July 25, 1958 - January 12, 2020

It is with an incredibly heavy heart that MLFD must inform you of the untimely passing of Harry Findysz. Harry was with MLFD for a relatively short time towards the end of his fire service career, but his impact was far-reaching during his tenure. Harry was an instrumental part in the evolution of our fire district.

Harry began his career as a firefighter with Rural/Metro Fire, where he quickly moved up the ranks to oversee their wildland division. Harry built a brand of quality while he was there that would cement his legacy in Southern Arizona firefighting. While never big on recognition, Harry held titles of Firefighter, Engineer, Captain, Battalion Chief, Assistant Chief, and Fire Chief throughout Pima and Cochise counties.



After the Bullock Fire in 2002, Harry was recruited to be a team member at MLFD. Harry quickly made his presence felt with his wealth of structure and wildfire knowledge. That knowledge would be put to the test on June 17, 2003 as the Aspen Fire began to rage. Harry worked tirelessly throughout the following months in capacities that cannot even be adequately appreciated. He is credited as being one of the last to evacuate the inferno and one of the first back in to fight the blaze. His efforts saved numerous structures, and his leadership was ever-present during the entire firefighting effort. After the fire, Harry, again, gave all his effort to the immense cleanup process that needed to take place. Harry oversaw the sawyer program that was put in place to remove dead-standing trees from private property throughout the community. During these trying times, Harry never wavered in his support for the residents atop Mount Lemmon.

Harry was passionate about everything he did. He dedicated an immense amount of time and dedication to mentoring upcoming fire service members. He ran the Rural/Metro explorer program, which has left a legacy in Southern Arizona. In total, Harry has mentored Chief Officers, Captains, Paramedics, Firefighters, and many others outside of the fire service. Harry helped develop MLFD staff members and recruit and train our volunteers. Not only did Harry assist us by helping fix everything imaginable, but he also helped build and maintain the radio system that kept our District functional.

After retiring from the fire service, Harry knew he would not be able to sit still. Beginning in 2005, Harry began to fulfill a dream that he had put on hold for many years while being a model public servant. By 2010 he had built a business from the ground up. Today, Southern Arizona Video Productions is a staple in the film


community and a market leader in their field. Raised a Tucsonan, Harry made sure his company was a local asset to the community. He was a long running supporter of the Tucson Rodeo and was always filming at Old Tucson Studios.

Truth be told, I could take up the entire Echoes newsletter writing about Harry's importance to others, integrity to self, and overall generous heart. As it stands, his accolades and accomplishments are simply too many to list. More importantly, Harry would hate to think people were reading this tribute; he was never a bragger. Still, I hope we have provided a glimpse into who Harry was for those that had not met him, and trust we drew upon many fond memories for those that did. Harry will truly be missed.

#### CHEATGRASS: A Near and Present Danger by Lindy Brigham

Our cheatgrass season is approaching. Wherever cheatgrass grows, unwanted wildfires burn hotter, more frequently and disrupt fragile ecosystems. More to the point on the mountain, your cabin is at risk if there is dry cheatgrass near it. Around the end of March start looking for signs of cheatgrass. It is hard to identify before it goes to seed, but if you know where to look you will see it. After it goes to seed, we only have a short time to get rid of it, either by pulling or spraying. Once the seeds are ripe, they disperse easily, and pulling just spreads them more.

Remember, it is your responsibility to manage the cheatgrass on your property, so not only are you safe, but you won't keep infesting your neighbors. You can pull it or spray it. We will have more information in the coming weeks on options for tackling the cheatgrass and where to get necessary supplies.

If you know you will need help, PLEASE ASK! (Lindy: labrigham@msn.com) The Fire Department has graciously taken on the responsibilities of the 50-gal sprayer and the backpack sprayers. We will be asking folks to help them out this season, so be prepared.

# Santa Catalina Ranger District Welcomes New Fire Management Officer

The Santa Catalina Ranger District of the Coronado National Forest welcomes Ian Morgan, Fire Management Officer of the Catalina-Rincon Fire Program. Ian will begin his permanent assignment on March 1, 2020 and brings a wealth of experience and leadership in complex fire programs.

Ian holds a Bachelor of Arts degree from the University of Washington in 2001. Ian's focus in school was Geography with an emphasis in geographic information systems and urban planning. Upon graduation, Ian began his career with the Forest Service in North Bend, Washington, working as an engine crewmember for the Mount Baker-Snoqualmie National Forest. Throughout Ian's career he has worked on seven National Forests in six states and four Forest Service regions, serving as a hotshot, fuels technician, and assistant fire management officer. Most recently, Ian worked as the assistant fire management officer for the Nogales Ranger District of the Coronado National Forest.

The majority of Ian's career has been focused as an interagency hotshot crewmember fighting fires throughout the West, spending half of his career working on the Okanogan-Wenatchee National Forest in central Washington State. Ian and his wife, Breanne, have a 5-year-year old daughter named Ani and live in the Tucson area.

#### Mt. Lemmon Water District

In a letter dated June 15, 2015, the Mt. Lemmon Fire District board and then chief Randy Ogden, made a formal request to the Mt. Lemmon Water District for a water line from our existing system to the MLFD facilities and the adjacent U.S Forest Service helipad.

Since that time almost five years ago, it has been a MLWD goal to help find funding and logistical mechanisms to enable this improvement. It is important to note that we were always aware that this would never be a water revenue driven endeavor. The only additional metered customers would be the MLWD facilities and the USFS access if helipad water access was ever utilized for fire suppression. From the 2015 letter forward, the common-sense benefits for the MLFD, the safety aspects for the public, and the greater good of the mountain community were the reasons for this water system addition. We were, as a board and a district, driven by benevolence and goodwill, and we remain so motivated.

With those public service goals firmly in mind, we had meetings with congressional representatives, local contractors (also friends of Mt. Lemmon), Arizona legislators, and Pima County elected and appointed officials from 2 or 3 election cycles. Throughout the years MLWD and MLFD were fully engaged in all the efforts towards this goal.

In late 2018, at a community meeting with Arizona Senator Gail Griffin, one of our board members, Gordon Hunter, had a "by-the-way" moment with Senator Griffin, which gradually led to heroic efforts on her part along with many other community members' efforts to obtain a funding source from the general budget via the Arizona Department of Forestry and Fire Management to the MLFD for \$750,000 for this project.

At this writing, the mountain snow remains on the ground, and your two mountain districts are on the verge of signing an Inter-Governmental Agreement (IGA), hiring a National Environment Policy Act (NEPA) contractor, gaining USFS and Pima County DOT approvals, and polishing preliminary engineering and project development plans. Our window for project construction remains late summer/early fall (post owl season) of 2020. Oh, and by the way, our state funding window ends in 2021.

So we hope your mountain thoughts and energies are urging us along, as your Water District and your Fire District herd all the cats, line up all the ducks, and finally get the dirt flying to complete this long-desired project on time and within budget.

Thanks for everybody's support in 2020.



# March Mountain History 76 Years Ago

On March 18, 1944, B-24H bomber, serial number 41-28874, with full combat crew, took off from Phoenix AZ headed to Texas. After Texas, the bomber was scheduled to continue east, eventually reporting for combat duties overseas.

As the B-24 passed over Tucson, severe weather, limited visibility and icing conditions were encountered east of the Catalina Mountains. The crew attempted to fly out of the weather and return to Phoenix, but the B-24 crashed in the Catalina Mountains, killing all 10 men on board.

According to the Army Air Forces mishap report, the bomber's lower right rudder struck a mountain peak in the area ENE of present-day Gordon Hirabayashi Recreating area. The plane disintegrated in flight, scattering debris for approximately 4 ½ miles. During WWII, the aircraft accident committees didn't have black boxes, cockpit recorders, and detailed weather information. As a result, Army Air Forces personnel had to hike into the crash site to determine the cause of the accident by looking at remaining debris.

Since the mishap report did not provide any information (photos, maps, or documentation) indicating which peak the B-24 may have struck, there is a possibility that the B-24's rudder may have fallen off in flight during the violent storm. In 1942, another B-24 crashed east of Florence AZ after one of the rudders fell off after encountering severe weather. Also, weather conditions were so bad at Davis-Monthan Field on March 18th, flying was called off until conditions improved. While we may never know the cause of the accident, ten men lost their lives: Judson T. Holmes, Randolph Aspinwall, James P. Smith, Merle O. Norlie, Lloyd G. Kadel, William A. Scully, I. Rybinsky, Harlin S. Darby, Howard W. Binne, and Charles Bishop.

At one time, debris from the big bomber could be seen from Windy Point scattered across the mountain. Salvage operations approved by the Forest Service in the 1950's resulted in much of the wreckage

being smelted into aluminum ingots and packed out. However, due to a combination of rough terrain and a large debris field, small parts of the wreckage remain. On one visit to the crash site, I came across the identification dog tag of James P. Smith, Bombardier of the B-24. After a few years of searching, the dog tag was returned to Smith's family.


The B-24 was a four-engine bomber. Due to the shape of the fuselage, it was nicknamed the Flying Boxcar. Over 18,000 B-24s were built to support the war effort. One is on display at the Pima Air and Space Museum.

Chris McDoniel has visited seven crash sites in the Catalinas, but there are still a few others he'd like to track down. One day, he hopes to build a more permanent exhibit or museum in the mountains of Arizona honoring aircrews involved in crashes. For additional information, visit www.AerospaceArchaeology.com




