

## About your Mt. Lemmon Homeowner's Association

Mt. Lemmon Homeowner's Association (MLHOA) was formed in 1969 to protect the welfare of the Mt. Lemmon community and to be involved in all aspects of its improvement. The concerns of the organization are not limited to private property owners, but the mountain community in general. Full membership with voting rights is accorded to private owners and leased land holders upon payment of yearly dues; renters and friends of the mountain can be non-voting members. Being organized, having a legal fund and having active local voice participation enables the Association to accomplish most of its goals. The Association organizes social events such as potlucks, pancake breakfasts, ice cream socials and raffles, enabling owners to mingle. The Annual Dinner and Meeting is traditionally held each year on the first Tuesday after taxes. Unfortunately, most of these events have been canceled this year due to the current health crisis.

Pima County has said the MLHOA is the strongest and most respected homeowner's organization in the entire county.

Fortunately, with two vaccines in release and two more expected, the endless loop might in fact end soon. Know that we are not at all satisfied with the vaccine rollout program and its glitches, and promise to keep your needs in front of the Pima County Health Department.

As much as these days and months have felt repetitive, you should know about some changes.

Please join me in welcoming Lt. Derek Ogden as our new Pima County Sheriff's Department Rincon District Commander. We have had the pleasure of working with Lt. Ogden during his previous assignment as Green Valley District Commander, and he shares our affinity for all things Mt. Lemmon.

Our office relocated in January to 33 N. Stone Avenue, Floor 11 (the former Bank of America Building) from the County Administration Building where plans call for the eleventh floor to be asbestos remediated and redesigned.

#### **MLWD** Bids Farewell to an Icon

Gordon Hunter is retiring from the Mt. Lemmon Water District board after many years of service to our mountain community. He has been here for continued community advancement and support for years. As a water board member, Gordon Hunter began with a white paper discussing the condition of the water supply and system at that time. This paper gave the story of an aging water supply and distribution system. The MLWD Board of Directors listened to him, and with his direction the water district realized there was much work to be done and became the chief instigator setting forward motion to the District. He made important decisions to improve both transmission and distribution of water to the community. Hunter implemented larger main lines, fire hydrants, regulator stations, meter upgrades, GPS mapping, remote monitoring, and automation where possible and district-supported decisions on priorities and schedules. His continued hard work brought this water system into the 21<sup>st</sup> Century. Without his leadership and continued community support, we would be eons back in history. All of us are grateful to Gordon Hunter for his community dedication and remain hopeful he will continue to support our efforts. Our community is a much better place with his help; thank him for our improved community.

Please welcome our newest elected water board member, Mr. Stu Shacter. He has stayed involved with the water district and attended board meetings for some time now. We want to thank him for stepping up to this position.

#### **Water District Concerns**

As all of us are aware, we are in an **Exceptional Drought**, the driest year in our history. We remain in Stage 2 of our Curtailment Plan, so please continue to conserve as much water as possible during this drought period. Your help is necessary to keep water in the tanks for both firefighting and home use. Remind your renters and visitors not to waste our precious water. Your community effort has and will continue to aid in this time of drought to keep our water system sustainable. As summer approaches, we will keep you informed of possible changes on the water availability status. Without substantial rain or snow we could be forced into Stage 3 of the plan. Stage 3 has a 50% reduction and is mandatory. With conservation and added precipitation we will make it into the summer. Stay aware of the water supply situation. Be sure to have extra water for emergency outages. Have extra drinking water and **Conserve!** See you this summer and have a Happy 2021!

#### What's New with MLFD in 2021?!?

Since we have been without the Echoes since November, MLFD would like to take the time to update our residents with some of the things that have been happening with the District, and MLFD has had some really exciting things happening. MLFD, along with our community and stakeholders, has been working tirelessly to improve the service delivery to our customers, safety of our staff, and the overall condition of the station.

Water Line - With the incredible help of everyone involved, the fire station will finally be on the water line! Not only does this deliver safe water directly to our station, but it also eliminates the need for water tender deliveries to be pumped into the tanks directly above the station. This is particularly important during the winter months where slick roads and heavy water tenders present an unnecessarily dangerous situation.

**Generator** - Did you know the station's generator was first put into use in 1950? As the years have steadily crept by, it has become more and more difficult to obtain parts to keep it running. Our generator runs our power, radios, and phones. Without a reliable generator we would not even be able to receive dispatches in the event of a power failure. The community, spearheaded by Sally Crum, really stepped up to help us gain the necessary funds to purchase a reliable source of backup power. Thank you!

**Communication** - Through in-house grant work, MLFD has received funding to overhaul a lot of our radio equipment. This new equipment gives us the ability to communicate with dispatch if the county system fails, while also allowing us a more efficient way to work scenes with our volunteers.

**New Station** -The facilities task force continues to collaborate working on a new station design while simultaneously reaching out to possible stakeholders for the funds necessary to realize that dream. A new station will provide the new accepted safety standards for our firefighters to continue to provide the service our community expects and deserves.

**Training** - Your firefighters continue to strive for additional training to meet the ever-evolving demands of both fire and EMS. Most recently, our EMTs are learning new approved skills to help them further assist our paramedics. This is crucial since our community is a significant distance from the hospital.

MLFD remains committed to continued improvement for our community. These are some of the major upgrades we have been working towards. Between the Bighorn Fire and the Covid-19 pandemic, it has been hard on MLFD staff not to interact with all of you. We hope this update finds you in good health.




## Santa Catalina Ranger District News

New year, new Marshall Gulch! The Santa Catalina Ranger District has some exciting news to share. We will receive Great American Outdoors Act funding to implement renovations at the Marshall Gulch recreation site. We anticipate receiving the funding this year and commencing work shortly thereafter. The goal of the project is to restore areas along the creeks to more natural conditions, improve vehicle circulation and parking, and provide accessible recreation opportunities. We will replace restrooms, renovate the picnic sites and trailheads, install new bridges over the stream, and improve roads and parking areas, in addition to naturalizing the stream channel.

Also, we continue to evaluate and restore trails impacted by the Bighorn Fire. This has included installing gates and signs at recreation sites and trails to provide for public safety and the ability of the natural resources to recover. 

## Contribute to the MLBEA and Mask Up Today!

The Mount Lemmon Business Economic Association (MLBEA) was founded in 2018, at the urging of the Pima County Small Business Commission and as a tax-exempt organization under Section 501(c)3 of the Internal Revenue Code. The MLBEA is open to all businesses operating on Mount Lemmon, as well as those having a vested interest in promoting Mt. Lemmon. It was instrumental in the efforts to obtain a Federal Lands Access Program grant to improve parking in and around Summerhaven (with construction to begin in 2024-25). The MLBEA worked closely with Pima County to ensure prompt reopening of the Gen-

eral Hitchcock Highway to the public after the Bighorn Fire and today actively promotes Mount Lemmon to visitors near and far.

Ongoing projects include promoting redevelopment of the commercial lots that have remained vacant since the Aspen Fire, organizing events to draw visitors during off-peak times and working to address issues created by visitor traffic, including public-area trash collection.

To further these goals, the MLBEA is currently selling reusable cloth masks which were generously donated by a Mt. Lemmon cabin owner. These attractive masks are only \$8.00, all money going to the MLBEA for funds for summer events. 




