

#### Mt. Lemmon Realty Building, Gateway to Summerhaven

This is the second in our series of articles profiling Echoes advertisers.

Mt. Lemmon Realty was founded in 1937 by Tony Zimmerman. The current location offers prime views of Summerhaven. After spending a couple of afternoons in the real estate office, it's easy to see how connected the Zimmerman family is to Mt. Lemmon. Jenni started off cleaning cabins for her mom, while Mom Fran

managed numerous rental cabins back in the day. There probably isn't a cabin on the mountain they haven't been inside for one reason or the other! Fran and Bob Zimmerman have cut back on their real estate duties and turned much of the day-to-day responsibilities over to daughter Jenni.

Covid proved very interesting to the real estate market everywhere, but especially for Mt. Lemmon. Prices of properties have increased dramatically in recent years. It's estimated 50 cabins and lots sold in 2020 and another 25 in 2021. That's a lot of new faces on the mountain.

There are many choices when it comes to listing a cabin, but Mt. Lemmon Realty does have features that make it unique to the market. No one knows these dirt roads like the Zimmerman family.

Many times, selling a cabin is like selling the "family" home. It's guaranteed that Jenni won't get stuck while out showing a cabin, no matter the road conditions!

#### **Important Updates from the USFS**

Gordon Hirabayashi campground will be closed for the summer starting June 1<sup>st</sup>. Mexican Spotted Owl breeding is ongoing with the chicks expected to hatch sometime in June. Yellow billed cuckoo breeding season starts June 15<sup>th</sup>, and several bat species will commence breeding in June as well, with no threatened and endangered species of concern. As of May 25, **Stage 2 fire restrictions** have been put in place signifying the following:

#### AT ALL TIMES:

Igniting, building, maintaining, or using a fire, including charcoal and briquettes anywhere within the Coronado National Forest, including Developed Recreation Sites IS PROHIBITED. This prohibition also includes smudge pots and wood stoves.

Smoking outside (see Exemptions #3 below).

Blasting, welding, or operating an acetylene or other torch with an open flame.

#### FROM 9 AM to 8 PM:

Operating a generator, chainsaw or other equipment powered by an internal combustion engine for felling, bucking, skidding, processing, road building and woodcutting during industrial operations or firewood gathering capable of igniting a fire. (See Exemptions #4 below).

**Exemptions during Stage 2:** 

Persons with a written Forest Service authorization specifically exempting them from the effect of this Order.

Using a stove or grill that is solely fueled by pressurized liquid petroleum or pressurized liquid petroleum gas (LPG) fuels.

Smoking within an enclosed vehicle or building, a <u>Developed Recreation Site</u>, or while stopped in an area at least three (3) feet in diameter that is barren or cleared of any flammable material.

Persons operating generators with an approved spark arresting device in an area that is barren or cleared of all overhead and surrounding flammable materials within 3 feet of the generator.


Any Federal, State, or local officer, or member of an organized rescue or firefighting force in the performance of official duty.

## The Cost of Everything, and the Value of Water

Welcome to June on the mountain. Hopefully, the above caption has your attention, as summer arrives with the drought conditions, and USFS Stage 2 fire restrictions begin.

Your MLWD is committed to use all revenue sources to improve water quality and distribution system, and address the safety of our customers and mountain visitors. We strive to keep all revenue dollars on the mountain.



The tiered excessive water and service establishment fees are two fee structures the MLWD Board will be evaluating and adjusting upward over the course of our summer meetings. All customers are welcome to attend our meetings which occur on the third Saturday of each month from 8:30 AM until 10:00AM at the MLWD office on Sabino Canyon Parkway (Zimmerman School building).

What does this mean for most water customers on the mountain? As a responsible, established water customer, it means no changes at all. Changes would primarily cover costs in initial service establishment or for wasting precious Mt. Lemmon water.



All MLWD customers are encouraged to turn off water when leaving cabins, and if you lend or rent out your cabin, instruct guests and tenants to do the same. Cabin owners are responsible for any leaks on their side of the meter. Tiered excessive water rate changes are intended to minimize those water loss situations.

YOUR water district is here for you, our customers. As the well-publicized and obvious Western American drought situation continues, we welcome your input and participation in all decisions made by your board and appreciate your cooperation. Have a wonderful and safe and fire-free summer!

#### From the Desk of Supervisor Steve Christy

Well, it's June, and the promised mountain roadwork has not started, much less near its scheduled completion. In May, the District 4 office received a memo from the Transportation Director, via the County Administrator, that stated the following:

"Summerhaven – Bid Opened April 20, 2022, and we received zero bids from contractors. Reasons provided were no capacity to take on additional paving work in FY 22, availability of trucks for asphalt, material plants running nearly at daily capacity, and cement shortage, as well as the inherent fire danger caused by the current dry conditions. We will rebid this package and provide a new completion date of October 1, 2022, allowing the contractor a few weeks after monsoon season to complete all the work."

We know our disappointment is exceeded only by yours. We met with County Administrator Lesher and Carmine DeBonis, Deputy County Administrator for Public Works, to voice our concerns with the management of the Mt. Lemmon road repair program. In essence, they reiterated the paragraph above, several different times and ways. We learned the project's bid window opened again in late May, and the District 4 office will receive bi-monthly progress updates. We shall see.

As I write this, the USFS just declared Stage 2 fire restrictions. Our great Sheriffs' Auxiliary Volunteers and the updated fire safety flyers are ready to go at Milepost 0. (Remember the Short Road short cut!) The Transportation Department will be deploying roadside signage. We have asked the Communications Department to dust off the public service announcement. Additionally, we have worked with the USFS and PCSD to get the electronic sign at the base to flash the Stage 2 fire restrictions message.

We are washing our cars to make it rain. Hope the clouds gather soon.

#### Mt. Lemmon 4th of July 2022 Parade Rules Regulations Agreement

<u>Time:</u> The Parade starts at 12:00 PM sharp (weather permitting). Please have your entire group present absolutely no later than 11:45 AM. Traffic might be heavy, so remind everyone in your group to arrive early!

<u>Place</u>: At 11:00 AM our Check-In table will be located at Loma Linda Extension /General Hitchcock Highway across from Ski Valley Road. The official Parade Route is on Sabino Canyon Parkway from the Mt. Lemmon Realty driveway to the Mt. Lemmon Water District.

<u>Check-In:</u> Please read, sign and return this form via email (pre-check-in) so you will only need to pick up your Parade Line Up Number on site at the check in desk. If you are unable to pre-register, you or a designated member of your group must sign this form on site. However, you must have previously submitted the registration form providing details of your entry which determine your placement in the line-up.

<u>Staging:</u> You/your group will then be directed to one of the staging areas located along Ski Run Road, Loma Linda Extension, Bisbee Avenue, or General Hitchcock Highway.

<u>Parking:</u> You may park in the staging areas provided that you are well off to the sides of the roadway. You may also park at the end of the Parade Route (Mt. Lemmon Water District) and exit via Middle Sabino Road.

<u>Certificates/Awards:</u> Participation Certificate will be given to each Participating entry at the end of the Parade Route and Award Certificates will be distributed at the Mt. Lemmon Community Center following the Parade.

Water: Bottled water as well as restrooms are located at the Mt. Lemmon Community Center.

#### PARADE ETIQUETTE

- All efforts must be made to keep the Parade moving at an even pace without gaps causing spectators to believe it has prematurely ended! That requires your undivided attention!
- Singing, dancing, playing music must be done while walking the Parade and maintaining an even pace.
- NO PERFORMANING AT JUDGES' STAND: Only pause long enough for the Emcee to announce your group!
- NO stopping for spectators to pet animals.
- Spectators are to sit or stand on either side of Sabino Canyon Parkway.
- Small children must be accompanied by their parents.
- Animals must be harnessed or leashed and with their owners at all times.
- There may be NO political entries.
- Water may be shot into the air overhead; NOT into the crowd. NO WATER CANNONS ARE ALLOWED!
- No candy, frisbees, nor objects of any kind may be thrown into the crowd! Candy, etc. may be passed directly to spectators or at their feet, Do NOT provide any incentive for children to run into the street.
- Parade Participants including children when reaching the end of the Parade Route must NOT turn and walk back through the
  on-coming Parade! Please have a pre-arranged plan to accompany children and by your example walk behind spectators to
  return participating children to their parents.

#### About your Mt. Lemmon Homeowner's Association



### **Sky Island Escape** by Dan Leade, Capt/A-shift

After a strange few years, it has been a very nice change of pace to see so many of you in person. As I write this, we are only one week away from our back-to-Annual Firewise Block Party (although by the time you read this it will have already occurred). This is such a great event for the education, networking, and catching up with friends. The Mount Lemmon Fire District has always contributed to the block party by providing some informal fire and life safety education and games but beginning this year, we have formalized the process. With the invaluable direction and assistance of Laura Gunia, Christina Grossman with the Sky Island Kids Club, and Diana Osborne, not only do we anticipate this program to be a success, but we hope to feature continued lessons annually for youth fire safety.

Since we are aware that not everyone may be able to attend or may be participating in other activities at the event, and knowing that many of you have children or grandchildren, it seems prudent to make the information from our presentation available to all. We will be providing age-specific fire safety messages such as: Stop Drop & Roll, having an Escape Plan, and basic campfire safety. While all of these are important, for the purpose of this article, we will be highlighting having an escape plan. This is because, for many of you, your cabin is a gathering place that children/grandchildren may be less familiar with, and under the duress of a stressful situation, they may become more easily disoriented than in a place more familiar to them. This makes having an escape plan critical in the event of an emergency.

When a smoke detector goes off, assume that there is a fire near your location. Follow the steps and await an adult to confirm that no fire is present. Begin by getting on your hands and feet and stay low. Smoke and heat rise, so get low and stay low. Feel the door (back of hand) to see if it is hot. A hot door means there is something even hotter on the other side. Use the back of your hand to not burn the part of your hand needed to escape. NEVER go back inside once out! Go to a meeting place to await a parent/guardian/fire department, and then call 911.

We believe that teaching fire safety at a young age is crucial to fire safety-conscious children growing into fire-responsible adolescents and adults. We are extremely grateful to everyone who had a hand in putting on the Firewise Block Party to provide us a forum to deliver our message!

Pima County Board of Supervisors declared May 7<sup>th</sup>, as Wildfire Community Preparedness Day in Pima County. This is a day set aside nationally for communities to work together to "Reduce the Risk of Wildfire." **Thank you to the Mt. Lemmon Cookie Cabin** that provided cookies which were distributed to many of you out working that day. While we were cautiously optimistic that our chipper crews would arrive the week of the 9<sup>th</sup>, unfortunately they were called to respond to wildfires. The Mt. 
